Response: The Nassau County School District will take the following actions to involve parents in the joint development of its district-wide parental involvement plan and LEA plan:

- 1. Invite the parents of each Title I student to attend and participate in various Parent Involvement District School Advisory Council meetings, as well as their child's school-based School Advisory Council. Any parent who chooses to attend will be considered a member of the group. The voting members of the District School Advisory Council, as well as each school's advisory council, are elected by their peers at the first meeting of each calendar year. These groups are responsible for the development, implementation and evaluation of the LEA Parent Involvement Plan.
- 2. Ensure all Title I principals place the Title I Parent Involvement Plan on the October school advisory council agenda for parental review. School Advisory Council members are elected in accordance with each individual school's SAC by-laws, but the SAC meeting is open to all parents.
