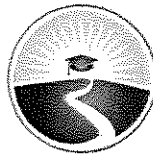



**Response:** The LEA District Parent Advisory Council (PAC) is a consolidated advisory group that serves Title I, Part A - Migrant and ELL Programs. The Council membership is composed of two representative parents from each Title I school and the participating private schools. In addition, five Migrant Education Program parents whose children attend Title I schools participate. The council members provide input into the development, implementation and evaluation of school related plans/ activities, including but not limited to the District Improvement Plan, the Local Education Agency Plan, Parental Involvement Plan, and the Title I, Part A application. Parents participate in the development of the Title I activities and therefore the Title I budget in their District PAC role. All meetings are documented through sign-in forms and minutes of the meetings which reflect parental participation in decision making.

Decisions involving the use of the Title I funds reserved for parental involvement at the school level will be made during the development of School Improvement Plans by the School Advisory Committees (SAC). Parent members are selected by parents. Fifty-one percent or more of the SAC members are parents with two being community representatives. The LEA will monitor SAC memberships to ensure that parents are involved in the process. Schools receive training and information from the Office of Instructional Services and from the Title I Program on ways to increase parental involvement and how to involve parents in the on-going development and monitoring of School Improvement activities and plans.

Funds reserved for parent involvement will be spent on school site parent liaisons, parent resource centers, and support activities and materials for parent and family engagement workshops.

**Response:** The Martin County School District will provide the following necessary coordination, technical assistance, and other support to assist Title I, Part A schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance:

-Technical assistance is provided to Title I School administrators through 3-4 meetings annually. At these meetings district Title I administrators review school achievement data, assist in the modification of school improvement activities and provide training, information or implementation support for required plans.

-At the beginning of each school year, the Title I Program provides Title I School Principals with an updated Title I Principals' Guide. This Guide provides principals with guidance on parental involvement requirements and how to implement parental involvement components.

-Each Title I school has a Parent Liaison who facilitates parental involvement activities and serves as a contact/ resource to parents. The Title I Program staff meets monthly with Parent Liaisons to educate them on parental involvement strategies and to provide support to the school.

-The Title I Program School Level Comprehensive Needs Assessment provides schools with guidance to review their effectiveness in fostering parental involvement and in educating parents on testing, the Florida State Standards, and monitoring children's progress. District Title I staff meet annually with school administration on how to implement the Comprehensive Needs Assessment process.

-District Title I staff meet annually with school administration and teachers to inform them about the two district Parent Resource Centers and how to support students' academic performance by utilizing the PRC.

-Title I schools will send their school parent involvement policies to the Title I office for review prior to submitting them with their SIP. A checklist will be developed to determine if they meet Title I requirements and revisions will be requested to meet FDOE standards.

## Annual Evaluation

**Response:** The Martin County School District Title I/ Migrant/ and ELL Parent Advisory Council (PAC) meets formally two times times per year. The PAC helps to develop/ revise the District's Parent Involvement Policy, to determine how it is distributed and to suggest improvements for parental involvement activities and other Title I activities in schools.

The LEA Parental Involvement Policy development consists of a process that follows the requirements of Section 1118(a)(2)(E). This process includes developing/revising a parent survey that addresses the six indicators of quality parental involvement programs, evaluating survey results and utilizing this data to guide in the development of the Parent Involvement Policy which includes strategies and activities to increase parental involvement and the capacity of parents. Survey development by the PAC occurs in the fall. Surveys are distributed in early spring and considered by the PAC later in spring. Also, the PAC discusses the current school year PIP and the activities initiated. The PAC uses this information to identify areas of concern and barriers for parental involvement and to suggest parental involvement activities for the upcoming school year's PIP.

The annual evaluation is conducted in part by the Parent Advisory Council, the district Title I office, Parent Liaisons and school site Principals. The Parent Advisory Council helps to develop annual surveys that are distributed to all Title I school parents and families. Parent Liaisons along with school administration distribute, collect and tabulate the results. School results are submitted to the district Title I office for evaluation and planning purposes. Results are also shared out at a biannual Principal/Assistant Principal meeting.

**Response:** Parental brochures are printed in both English and Spanish. In addition, other written communication will be provided for parents in English and Spanish. Translators who speak Spanish are available at all parent meetings and in school offices to provide translation services and to ensure that parents are able to fully participate in parent meetings.

District level translation of both school and district documents is on-going. In addition, other language translators are available, as needed, in the following languages: Arabic, Chinese, French, German, Korean, Japanese, Polish, Romanian, Thai, Vietnamese and Haitian Creole.

Parents with disabilities have access to parental involvement activities as school facilities are ADA accessible and staff assistance is provided, if needed. Parent Liaisons conduct home visits, as needed, to accommodate specific needs.

Critical documents that have been distributed and relate to Title I and school improvement are maintained in a binder in the front office and accessible to parents who may enroll their children throughout the school year.

Requests for document translations are made to the Title I office and allow the LEA to monitor that schools provide information to parents in a language they can understand. Also, monitoring documentation collected by schools and reviewed by district Title I staff include translated documents.
