**Response:** The LEA provides technical assistance to assist Title I schools in planning and implementing effective parent involvement activities during July of 2015 and continuing until plans are complete. Ongoing assistance is provided during the school year as needed. In addition the LEA monitors/evaluates the implementation of plans through quarterly reports of activities to the District Advisory Council, review of sign in sheets, attendance at school parent involvement activities and end of the year parent surveys as appropriate. Technical assistance includes but is not limited to the following; information provided in the Parent Involvement Tool Kit, technical assistance provided by the department and articles documenting the positive correlation between parent involvement and academic success. The Director of Instruction provides face to face training during leadership team meetings, as well as technical assistance as the plan is being developed via email and phone calls. **Response:** The LEA has a small Spanish speaking sub-group in the district. A concise summary of the PIP in the form of a brochure will be translated into Spanish and distributed to all Spanish speaking homes in the district. The district will coordinate with Student Services Coordinator to provide this service. The district will provide this information to schools for distribution. Schools will be required to verify in writing that the information was provided to all identified parents.

Information regarding parent involvement activities will be sent via student back pack to ensure that parents are aware of scheduled activities at each school site. School staff will verify in writing that materials have been distributed.

Parents make up the majority of the District Advisory Council. These parents are solicited to determine the types of parent involvement activities they would like to have available in the district. All parents are surveyed to determine the level of satisfaction with parent involvement activities provided in the district.

Climate surveys are conducted by each school that incorporate specific questions related to parent involvement activities.
