Response: The School District of Osceola County (SDOC) has created a District Parent Advisory Committee (PAC). Parent representatives from District Title I public and private schools and members of the community, are invited and encouraged to join through various outreach efforts. The PAC provides input into the development of the LEA Plan, the District Improvement and Assistance Plan, the District Parental Involvement Plan (PIP), the Title I Part A application and how Title I funds will be spent for parent involvement. This committee, along with the Director of Special Programs and Special Programs staff meets bimonthly September - April. Items pertaining to Title I, but not limited to, the Title I Budget, parent involvement expenditures, current efforts and review/revision of the PIP are discussed with participants of the PAC. During meetings minutes are recorded to document input from parents, as well as other information discussed at each Title I PAC meeting. Special Programs staff is always looking to recruit more parents for the PAC. Our goal is to recruit at least one parent representative from each Title I School to join the PAC. Efforts to attain this goal include, but are not limited to: distributing flyers, sending emails, advertising events/meetings for parents in the car loop lane on a message board, attending school hosted events including School Advisory Council (SAC) meetings. All advertising and marketing materials are provided in English and Spanish.

To ensure that each Title I school in Osceola County meets with their SAC committee monthly, SAC meeting schedules are provided to the LEA. To help encourage involvement, invitations and reminders are sent home by the school via backpack. The meeting dates and times are posted on the school marquee. The LEA encourages schools to post these meetings on the school website in order to promote a need to volunteer and the importance of being an involved parent.

**Response:** The Title I Staff responsible for parental involvement meets with representatives from each Title I school to discuss best practices and strategies related to parent involvement, ways to help parents become involved, and to help parents monitor and improve their student's academic achievement.

They also provide training to all Title I schools for their administrators or staff member that are assigned to completing the Parent Involvement Plan (PIP) on the requirements that are mandated by the state. Upon completion of activities, sign in sheets, agendas, and evaluations are sent to the LEA Title I Program Specialist to ensure documentation of implementation. Schools that do not provide the required documentation of implementation in a timely manner are contacted and supported by the LEA to identify, address, and overcome barriers to implementation.

The School District of Osceola County provides a Title I mobile Resource Center for parents of Title I students and eligible private school students. Materials are available for check out for a two week period to help improve their child's academic achievement. The Title I Liaisons will work collaboratively with school liaisons to offer workshops and information to help parents work with their children at home. During a parent teacher conference the teacher will have access to a "Prescription for Success". This will enable parents to check out items that will help build skills for success and increase student achievement.

Parents also have an opportunity to check their child's grades on FOCUS, commonly known as the Parent Internet Viewer or PIV. To access the FOCUS Parent Portal, parents should visit the District website at

https://osceola.focusschoolsoftware.com/focus/ To register parents will need their child's school ID number and last four digits of their social security number. The FOCUS Parent Portal is a tool designed to enhance the communication and involvement of parents in their child's education. FOCUS will provide internet access to grades, attendance, discipline, academic history, graduation verification, and standardized test results in a secure password protected environment.

To ensure compliance, Title I Staff will review the school level PIP's in September through January utilizing the rubric supplied by FDOE. The LEA will assure that Title I schools are providing activities that are meaningful, equitable and provide parents with information to become more involved in their child's education. **Response:** The LEA meets bimonthly (September - April) with the Title I District PAC. During these meetings the PAC will review the District PIP. The PAC and LEA staff will develop a plan for evaluating the PIP, this includes modifying surveys to meet the needs of Title I schools in Osceola County. The survey will be sent home to parents with their students giving all parents an option to complete the survey.

http://www.osceola.k12.fl.us/depts/special\_programs/index.asp that can easily be accessed through a quick link for parents on the School District of Osceola County's website. The LEA is working to ensure that each Title I school will also have a direct link to the Special Programs website.

All written communication sent home is printed in English and Spanish. If a particular language other than English and Spanish is spoken by fifteen or more students, communication is provided to parents in that particular language. The Osceola Data Management System will be checked monthly to ensure that all information is being sent to parents in the necessary languages. The LEA will then contact the Title I principals that should be providing the necessary translations. Copies of all parent involvement information are requested to be kept in the Title I Monitor box. Accommodations for other languages are provided upon parental request. The District has equipped each school with translation devices to be used for oral translation during meetings. If a language other than Spanish is needed, the School District of Osceola County offers a district wide language bank. Employees throughout the District volunteer their services to provide translation in 48 languages including different dialects. Sign Language is also included on that list. If Braille is needed a transcription would be supplied.
