

Response: The LEA has established the FIC Teams to provide parents with educational information to help parents become more informed about school-related topics, such as standards, state testing, ESE service, etc. The FICT has also been established to act as an additional link between the district, parents, and community engagement. The input gathered from each school based FIC Team is used in the formation of the district level PIP. The SDMC will seek additional input from the District Advisory Council (DAC) which provides SAC training and technical assistance to school-based SAC representatives and principals. The DAC also reviews and offers input on the district budget and School Improvement Plan (SIP).

The LEA will invite other program representatives to participate in the family involvement activities. Programs including, but not limited to, ESOL, VPK, Head Start, Extended Day, Take Stock for Children, ESE, Homeless and Migrant are invited to give input into the LEA Family Involvement Plan. The team reviews the family assessment needs data, projected family involvement activities, and the use of family involvement funds. Once the plan is approved the TI PIP brochure will be sent to schools and posted on the district website. The brochure has a comment form that families may complete and return. The comments are used to assist in the review, implementation, and evaluation of the PIP at both the LEA and school level.

Each SDMC Title I school develops their Parent Involvement Policy (PIP) in collaboration with families via the School Advisory Council (SAC), family evaluation data, and/or family friendly focus groups. The SDMC ensures that each Title I schools meets with their SAC committee regularly and solicits input for the school-based parental involvement plan. Families are invited through invitations and flyers, and reminders are posted on the school marquees and websites, as well as through mass telephone notifications.

The Title I Team reviews and considers each school-based PIP as an integral part of the PIP planning process. The PIP will subsequently be shared and reviewed with the Title I schools' SAC committees in an effort to receive additional input and approval from families and other stakeholders. The SDMC receives input in a variety of ways including the collection and analysis of the aggregated data of family workshops and the annual Title I Family Evaluation.

Family Involvement surveys will be distributed in the spring and the results analyzed to evaluate school needs. Decisions involving the use of Title I Family Involvement Funds at the school level will be made during the Spring Title I Planning Session and is updated

based on the school-level School Improvement Plan (SIP), additional Family Involvement program data, and other stakeholder input.

All Title I Schools receive training and information on ways to include families in the school process, including school improvement. Training also includes gaining a thorough understanding of family involvement requirements for the LEA and the school. Five training's are held throughout the school year for building capacity and technical assistance.

Response: The School District of Manatee County will provide the following coordination, technical assistance and other support to the Title I Schools:

Each Title I School will establish a Family Involvement Contact Team and will receive technical assistance based on the need of the school and the best practices of family involvement. The Title I Coordinator and Specialists provide information, resources and support to schools to enhance their abilities in working with families. Title I FI will also coordinate with other Federal Program staff to support the Title I Schools' family involvement initiatives through planning, resources, and/or attendance. We will also assist schools with the creation of model family information areas that provide a variety of current materials for families.

The Federal Programs Director, Title I Coordinator and Title I Specialists will hold quarterly Principal's Meetings to provide technical assistance and model effective family involvement practices. Additional information and support to principals will be available as needed. Phone calls, emails, and an electronic resource page will be used to share and offer on-going support to principals and their Family Involvement Teams.

The Title I Coordinator and Specialists will review each school level PIP in the fall to ensure compliance and to encourage activities that provide meaningful opportunities for families to support their child's educational needs. These activities will be logged and aggregate data will be analyzed with the school FICT to measure the effectiveness of the family involvement activities.

In addition, an electronic resource will be available to support the Title I schools. There will be information on school data, Title I compliance and updates, family involvement resources, model workshops, sample presentations and other templates and community resources, etc. There will also be an area for sharing best practices across schools. The LEA has created and will maintain a Parent Center website for family resources and information.

Response: The School District of Manatee County will use a variety of data gathered from the Family Involvement Contact Team meetings, the Title I family Evaluation Survey, and the aggregate data from the school family workshop surveys to evaluate and improve the policy. The school will collect Family Involvement activity data throughout the year and the Family Evaluation Survey will be distributed in the spring of 2016. The Family Involvement Contact Teams will review the data and evaluate the school PIP for effectiveness on student achievement. Modifications will be made at that time.

Data from the Family Evaluation Survey will be disseminated to the schools and the Family Involvement Teams will review the data and evaluate the school PIPS for effectiveness on student achievement. Recommendations for modifications will be made at this time.

The district redesigned the family survey for the 2014-15 school year to reflect the 5 Essential Elements of School Improvement (Leadership, Collaborative Teachers, Ambitious Instruction, Supportive Environment, and Engaged Families). Of the 996 parent responses, the data reflects the following areas for improvement:

Increasing family participation in making decisions that affect the school and make it better.

Helping families connect to community services and resources.

Giving students multiple opportunities to apply what they are learning to solve real world problems that reflect their cultural experiences.

Increasing the effectiveness of preparing students for transitions between Pre-K to Kindergarten, elementary to middle, middle to high school, and high school to college.
