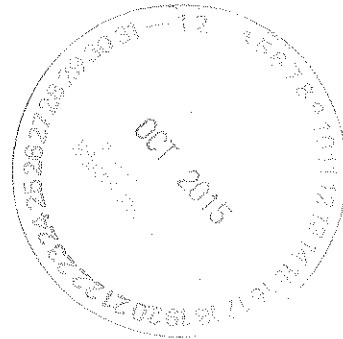





Response: The mission of the St. Lucie County School District is to ensure all students graduate from safe and caring schools, equipped with knowledge, skills, and the desire to succeed.

Response: The Local Educational Agency (LEA) employs a Title 1 Parent Involvement Specialist to coordinate parent involvement activities, initiatives and provide technical assistance for the district and Title 1 Schools.

The LEA has established a Title 1 Parent Resource Center. It is family-friendly, contains updated lending materials, house workshops, provide computers and internet access and will be located in an annex with other community-based resources.

The LEA has established a Title 1 District Parent Advisory Council (DPAC). The DPAC meets 4 times a year for general meetings. The DPAC provides input into the following:

- The development, review, implementation, evaluation and revision of St. Lucie County

School District's Parent Involvement Plan.

- Resources provided at the Title 1 Parent Resource Center.

- Title 1 Monthly Parent Event Calendar.

- Workshop offerings for parents, schools and teachers.

- DPAC meetings are scheduled on 8/2015, 12/2015 and 2/2016, 5/2016 - the meeting announcements, agendas, handouts and sign-in sheets will be collected as documentation. DPAC members and all invited parents review and evaluate PIP. Suggested changes from parents are made on the plan.

Board members will be voted into office: chairperson, co-chair, secretary and two at-large members. During the DPAC meeting, parent/s input is recorded into meeting minutes. Other participating members are selected by principals at each Title 1 school and any parent with a child attending a Title 1 School are invited.

The survey was available on the front page of the St. Lucie County School Board website from mid May, 2015 - June, 2015. Survey results were utilized in creating the 2015-2016 LEA Parent Involvement Plan. Individual school results were provided to Title 1 principals for their use in creating their 2015-2016 Parent Involvement Plan and activities.

The LEA provides technical assistance and trainings for Title 1 principals and ensures that the Title 1 School Parent Involvement Plan is available for parental review, commentary and distribution (e.g., online and/or written hard copy, School Advisory Council (SAC) agendas, school newsletters and/or websites, open houses and personal parent meetings).

The LEA provides technical assistance and trainings for Title 1 Principals on the Elementary and Secondary Education Act (ESEA) requirements and the process for distribution of Title 1 Parent Involvement funds to Title 1 schools. This is accomplished through Title 1 parent involvement trainings at the LEA office and individual trainings provided for principal's and parent involvement contacts at their respective school location.

The LEA utilizes the Title 1 Parent Involvement Survey and a variety of settings for soliciting parent representative input (e.g., workshops, steering committees, focus groups, SAC, DPAC, Parent Teacher Associations (PTA), open houses, community settings, events, meetings, telephone, written, and on-line).

Response: The LEA provides technical assistance and collaboration each school year for all Title 1 principals in their development, implementation and review of Title 1 Parent Involvement Plan.

The LEA also provides technical assistance and collaboration each school year with school leadership to ensure ESEA section 1118 requirements for districts and schools are met for the School Improvement Plan, Parent Involvement Plan and School Parent Compacts.

The LEA reviews each Title 1 school's Parent Involvement Plan to ensure that activities provide meaningful opportunities for parents to gain the needed skills and/or knowledge to become more involved in their child's education. The LEA has asked school level Parental Involvement Policy/Plans and evaluations be submitted for review on or before October 2, 2015.

The Parent Involvement Program Specialist participates in annual State conferences, webinars and regional trainings. As a result, the program specialist is kept abreast of the most current research-based findings, activities and programs for family involvement. This information is shared with principals, school based parent involvement contacts, Parent Academy curriculum committee and board members and DPAC members through monthly & quarterly meetings, emails, and in consultation with schools at school-based meetings.

Title 1 school staff, DPAC and Title 1 school SAC members are invited to attend Regional, District and State sponsored training sessions, workshops and conferences designed to support parent involvement and strengthen student academic achievement.

The LEA provides to all Title 1 schools professional development on the 10 components of Title 1 including Parent Involvement and Family-friendly schools. This training educates principals and their staff on how to reach, communicate and create a partnership with parents. Additionally the value of parental participation at their schools is emphasized and evidence-based outcomes are provided. Schools participate in Family-Friendly walkthrough surveys with staff, administration and parents. Results are reviewed by the Title 1 school staff, SAC, DPAC and the LEA to determine needs to be met in the school based PIP.

The LEA developed and has made available to all Title 1 Principals, DPAC members and school-based parent contacts, a Parental Involvement Workshop/Activities Guide describing all available parent involvement training resources. This guide is updated regularly throughout the year as additional trainings and resources are made available from the LEA and the community.

The LEA ensures that all Title 1 Schools submit to the Title 1 office notification of all parent involvement activities, events, and a copy of their monthly school newsletter. These documents and notifications are filed and serve as a school/parent activities tracking instrument. Additionally, the LEA requires copies of flyers, and agendas for all parent involvement activities (e.g., Five Star School Notebooks, Open House, Scholastic Book Fairs, Reading, Math and Science Nights, Families Building Better Readers, etc.).

The parent involvement program specialist plans and the LEA funds opportunities for guest speakers to provide parent involvement activities and workshops for the staff at Title 1 schools, DPAC meetings and at the Title 1 Parent Resource Center.

Response: The LEA reviews: School state test results, Family Friendly School surveys, Title 1 Parent Involvement Surveys and Parent Workshop evaluations. Feedback is obtained from DPAC, SAC, 21st Century, Early Learning Coalition and Title 1 school staff. The District Title 1 Parent Advisory Council (PAC) will meet 4 times each year to review and develop the implementation and effectiveness of the LEA PIP and plan parent workshops. In May, the Coordinator of State and Federal Programs, will review, revise and approve the plan. This meeting will also provide training to new committee members. The Coordinator of State and Federal Programs, meets with Title 1 Principals utilizing an audit checklist and Title 1 Parent Survey results to evaluate each school's parent involvement plan and activities. Survey results are reviewed to evaluate each schools' parent involvement plan in the spring of each school year. As the survey results are reviewed, barriers and best practices of parental involvement are discussed for future parental involvement initiatives and included in the new PIP.

Response: Workshops are offered at the Parent Resource Center in the morning, afternoon, and evening as well as at community locations including community centers, different school locations to accommodate the various needs of all families. Workshops are offered in other languages (Creole/Spanish) to accommodate the needs of ESOL and migrant families with translation provided by ESOL staff and Migrant Advocates. All sites have entrance and exit ramps to accommodate parents and students with physical disabilities.

Flyers will be provided in multiple languages and will include a request for parents to RSVP should they have a specific disability (e.g., sign language, hearing impairment, etc.) that need to be accommodated.
