Response: The purpose of the Jackson County School District is to prepare all students for success as educated and caring citizens by inspiring and building good character and a passion for lifelong learning- building a better community, one student at a time.

Response: The district-wide parental and community advisory council will be utilized to solicit input into the parental involvement policy and the LEA 5-year Plan. The council will meet four-ten times per year to review and update the policy and LEA Plan as necessary. The council will be composed of parent representatives from each school's School Advisory Council, community partners, school and district leaders in Graceville (two meetings), Cottondale (two meetings), Marianna (four meetings) and Sneads/Grand Ridge (two meetings). The district-wide policy will be incorporated into the Jackson County School Board Title I Plan. The District Parental and Community Advisory Council will be involved in the development of the District Improvement Plan. The school board meetings and workshops will be advertised prior to the meetings. During the school board workshop or meeting, parents will have an opportunity to address any concerns with the Title I Annual Plan and review and make suggested revisions to the LEA 5-year Title I Plan.

School review and improvement under Section 1116:

All schools in the district will organize a School Advisory Council (SAC), with the majority of its members not employed by the District. The SAC will serve as the decision-making body of the school. The SAC will meet quarterly to develop, review and offer suggestions for improvement of the School Improvement Plan/Title I School-wide Plan, as well as all other policies required by NCLB. The SAC will review data, discuss strategies implemented, and evaluate progress made by students.

The District Parent Advisory Council will be the determining factor to decide how the funds will be allocated to Title I schools. At the April 2015 Advisory Council meeting, the Director of Federal Programs provided several options for the Council to review. It was decided during that meeting the funds will be allocated based on the proportionate share of free and reduced priced lunch children at each Title I school. Allocation amounts are shared at the first meeting of the following year as proof of meeting compliance with the District Parent Advisory Council.

Technical Assistance

Response: The district's Director of Federal Programs will meet monthly and additional times as needed with principals to provide technical assistance. The district's e-mail system (Microsoft Outlook) will be utilized to provide technical assistance. The district will allocate Title I funds earmarked for parental involvement activities as decided on by the District Parental and Community Advisory Council. The Director of Federal Programs will visit Title I participating schools to offer assistance and support of parental involvement activities. The district will allocate professional development funds to Title I schools to assist schools in attending state conferences and Region I workshops.

The Director of Federal Programs will provide training to principal or school-level designee for parent involvement in the development of robust parent involvement plans for their school. Data will be reviewed to determine strategies to be implemented for the school year. Each school will submit their plan for review by the Director of Federal Programs. The LEA will utilize a checklist to ensure the plans meet compliance. Each school level parent involvement plan is presented to the School Board for review and feedback from the Board and citizens.

Parents have multiple outlets to contact school and district personnel to voice their concerns and suggest activities for parental involvement. All comments and suggestions are reviewed and are determined feasible for implementation by the Director of Federal Programs.

The district uses a website to translate documents into other languages, as appropriate. All documents will be reviewed to ensure the format and language that is appropriate for the

diverse population of our district. The District is using Google translate on the District website to translate into multiple home languages.
