Evans leadership, staff, and faculty have a strong belief in the importance of parental involvement and therefore have put measures in place to offer parent meetings on a flexible schedule. Through parent feedback we were able to conclude that it is very difficult for Evans' parents to attend events during the school day and parents prefer early evening activities due to their working schedules.

For parents who are unable to come to the school the Social Worker, SAFE Coordinators, and Evans Resource Teacher make home visits for attendance and academic purposes.

Parent, teacher, administration, student conferences are scheduled to accommodate parents in the morning, afternoon, and early evening.

Because of our strong belief in the importance of parental involvement Evans went one step further to develop The Parent Resource Center which is open during the school day both in the morning and afternoon, after school, and scheduled evenings to provide parents with flexible times to access informational and computer resources, as well as, workshops and activities.

The School Advisory Council meetings are scheduled monthly in the early evening.

Guidance and Evans' College and Career Resource Center will hold several evening events regarding subject matters that are important to students and parents such as financial assistance, curriculum and programs, and college and career. The College and Career Resource Center is a resource for students and parents helping them to plan for college and assisting them in completing the necessary steps. The College and Career Resource Center is open every day Monday – Friday during the day and scheduled evenings and Saturdays. Flyers, invitations, agendas, and sign-in sheets provide evidence of scheduled events.

Parents are able to monitor student grades on a regular basis through Progress Book. They are provided an access code, information, and assistance on how to use Progress Book through SAC and PTSA meetings as well as in The Parent Resource Center. The Parent Resource Center is open during the school day and scheduled evenings. Parents also receive communications from their student's teachers, the guidance department, as well as progress reports and report cards at the end of the reporting period.

At parent conferences guidance couselors, teachers, and parents will discuss how to ensure the student's academic success and what parents can do at home. Input is provided from all of the student's teachers. Parent conferences are scheduled by the teacher, guidance counselor, or parent.

Evans Community School provides Evans students, parents, and the community with support in an effort to ensure student achievement. Key compnents of the Community School are after school

interventions and enrichment, adult education, parental involvement support, Medical/Mental Health Services, and community and economic development. A Health Serivce Coordinator coordinates all Health Services for the Community School. Flyers, invitations, agendas, or sign-in sheets evidence all activities.

The Parent Recource Center was implemented at Evans High School in SY 2011 – 2012. A Parental Involvement Coordinator works with parents to assess their needs and then provides the workshops and resources needed and/or requested. The Parent Resource Center provides parents a comfortable environment, access to computers, and someone to assist them and provide information. Sign-in sheets evidence all activities.

At the beginning of the school year Evans will hold an Annual Title I meeting for parents, teachers, students, and the community to provide information on all Title I programs, the curriculum, academic assessments, and proficiency levels. Parents will learn about school-wide programs and opportunities for participation in decisions related to the education of their child. The meeting presents Title I program components through a PowerPoint presentation including the School-Parent-Student Compact. Title I resources, Title I funding, Parent Involvement Plan and Policy, and the Right to Know letter. Discussion is held on the parental involvement plan and the School-Parent-Student Compact to receive parental feedback through feedback forms. Parents complete a survey regarding the PIP and workshops or resources they would like. Parents also receive Title I information at school events including Meet the Teacher Night/Orientation, IB Potential Night, Open House, SAC, PTSA, and PLC meetings.

Evans High School provides parents with a description and explanation of the curriculum through several venues. The Curriculum Guide provides information regarding academic assessments; focus on student achievement, curriculum, student schedules, registration, graduation information and requirements. Events are held throughout the school year that emphasize the above such as IB Potential Night and the PLC, SAC, and PTSA meetings. Student Planners are distributed to all students which also contain curriculum requirements, assessments, and other pertinent information.

At the PLC, SAC, and PTSA meetings parents participate in school improvement decisions that will affect the education of their children. Parents also meet with teachers and counselors regarding their child's education and participate in making decisions that affect their child's education.

Progress reports and report cards provide feedback to parents on their child's progress as well as Progress Book which provides parents with up-to-date progress throughout the semester and an avenue to stay in touch with their student's teachers.

Parents continue to receive updates regarding curriculum, testing, academic assessments, and student proficiency through:

- School and District websites
- School newsletters
- Information sent home with students
- Emails
- Connect Orange calls
- Teacher contact

The school will monitor that the information was provided through agendas, minutes, Curriculum Guide and Student Planner dissemination, copies of the Connect Orange calls made, parent-teacher conference documentation, and copies of school and district websites, and newsletter information.

To provide full access and opportunities for all English limited proficiency, school reports, and informational letters from the school and /or district will be provided through Evans' ESOL department and ESOL Resource teacher, in the child's home language according to federal/state guidelines. Since Evans has a large population of Haitian and Spanish students there is an interpreter on campus during school hours and at school events upon request. Staff members and/or district personnel will be available to assist parents who have disabilities (visual, physical, hearing) and will
