Flexible Parent Meetings

To better accommodate our parents, Bennett Elementary will schedule meetings to be held at different times during the morning, afternoon, or evening. During the school year our teachers schedule individual parent conferences in their classrooms before, during or after school hours. Parents are given a summary of test scores, interpretation of these scores, and an explanation of possible interventions to support or to enrich their child. Parents are given materials and are shown strategies to help their child at home. Additional help and support for parents is offered at Title 1 family events scheduled throughout the school year. Childcare and translators are provided as needed.
