Response: We have a Parent Resource Center, a food pantry and a clothes closet available to our families and community. We have a monthly Parent Engagement activities for our children and their parents, with educational ideas presented to help parents work with their children at home. We send home flyers, letters and a monthly newsletter that give tips to our parents and will alert them of the services and events we offer as well as our marquee reflects activities for the students and parents to attend. The person responsible is the Title I liaison and staff members with administration. Parents are surveyed several times a year on their thoughts and ideas on our services here at school as well as via mail so we can get a well rounded idea of where to expand and what to offer as help. All of our Family Engagement activities are well received and well attended, as well as our Care Cabin is used by hundreds of people monthly. We average 100 to 400 people attending our activities.

Response: A school calendar is given to parents at the beginning of the year so they can plan ahead to attend events. We start very early in the school year to have meetings and events so parents are well informed of what the school year holds for them and their children. The curriculum at our school is explained and on display at curriculum nights and open houses for parents to peruse. Academic success, individual grades and achievement of students are discussed year round in parent/teacher conferences. Many of our teachers use class dojo so parents can see daily how their child is doing in school. Regular meetings can be set up with guidance or the behavior specialist for students who require specific help or for parents who need ideas or advice to help their children succeed. If necessary, parents can request and meet with a team of professionals to determine the best course of action to meet their child's needs. SAC and PTSA meetings occur monthly and those boards are open to any parents wanting to volunteer. Parents are able to reach teachers and have conferences as well as get information past the normal 8 to 4 daily hours of school. Communication blasts are sent out via the phone or text to let parents know of important dates or matters. Our doors are always open and we are very accessible to our families and parents as a resource to help their many needs.

Response: All parents, whether their child has a disability, is an ESOL student or speaks a foreign language, are invited to attend and participate in all programs provided by Casselberry Elementary. If need be, we can provide sign language or other interpreters to make sure each parent understands the material and programs provided by the school. Written flyers or pamphlets are provided in Spanish or other foreign languages if needed. We do not discriminate against any child or parent in any way, and open our doors to all. With the addition of a new Assistant Principal, we now have a bi-lingual administrator that adds to our ability to communicate with our parents. Our students are

exposed to Spanish classes once every two weeks for all grade levels so communication is easier for all. We have taught sign language to our students during Clubs who in turn can teach it to their parent as well. Our school newsletter goes out monthly, we have automated voice messages to parents, and our school marquee puts events up regularly in an effort to reach as many parents as possible to come and participate at and with our school and their children.
