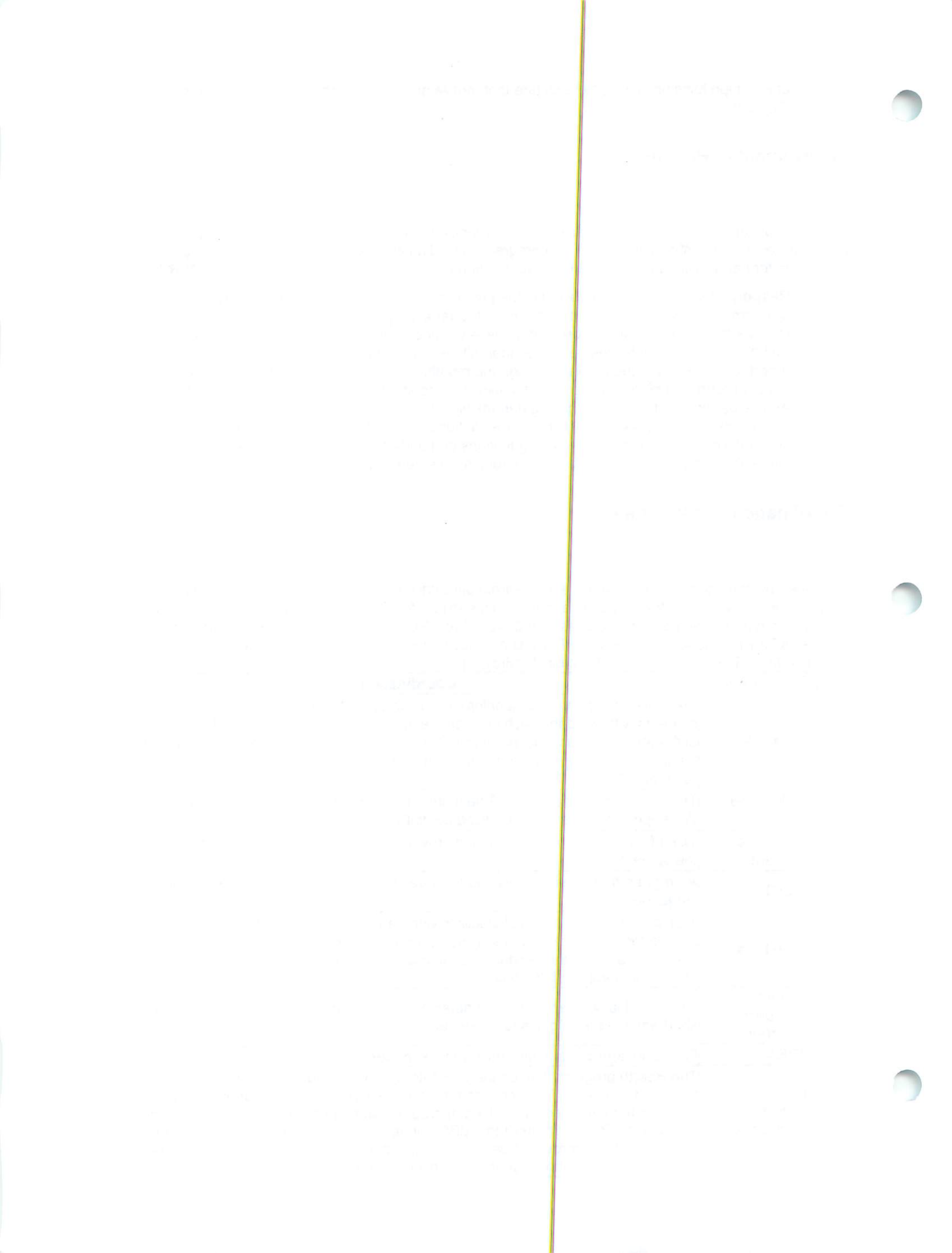

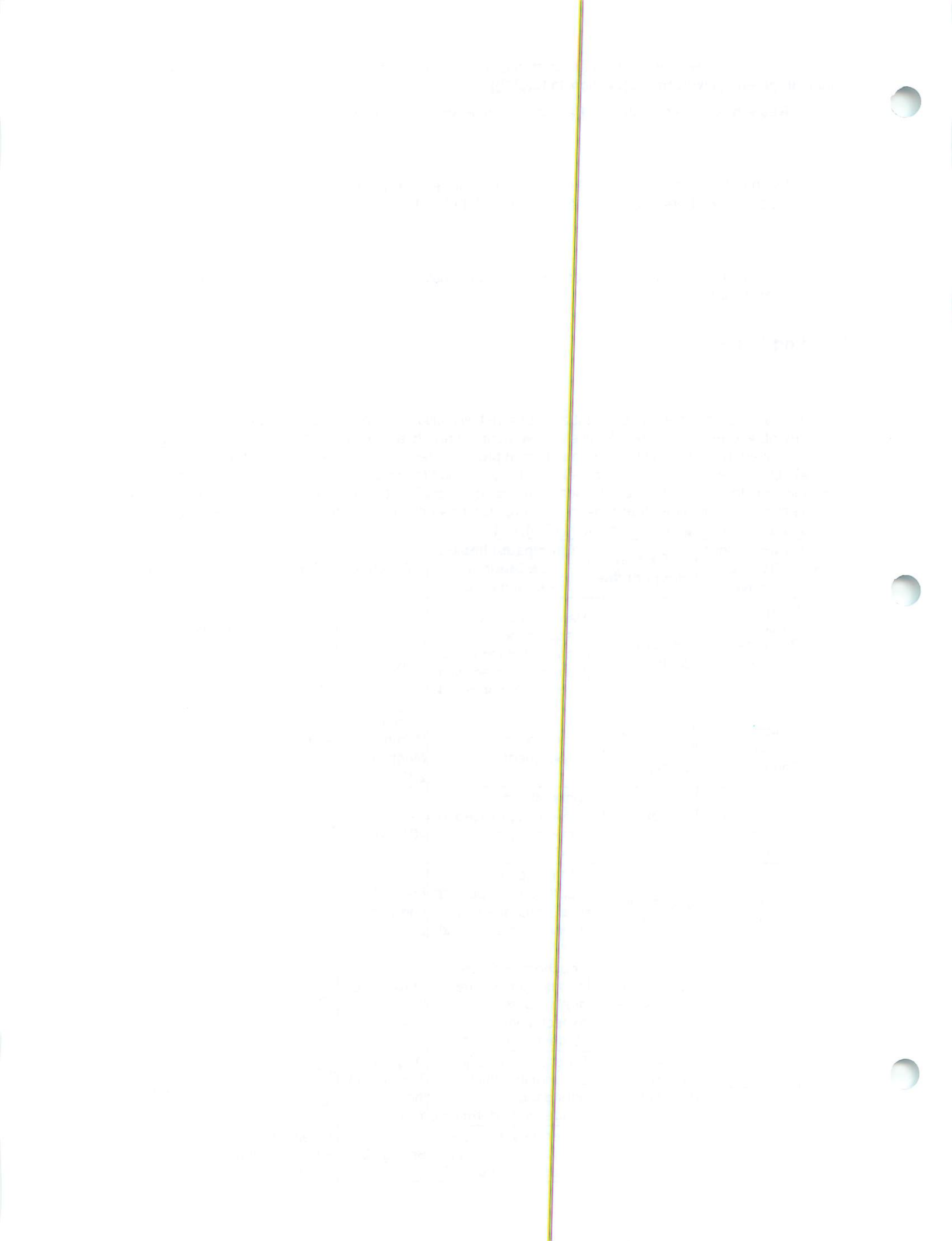
IEP meetings and parent/teacher conferences are scheduled through the classroom and resource teachers throughout the year from 7:30-3:30PM.

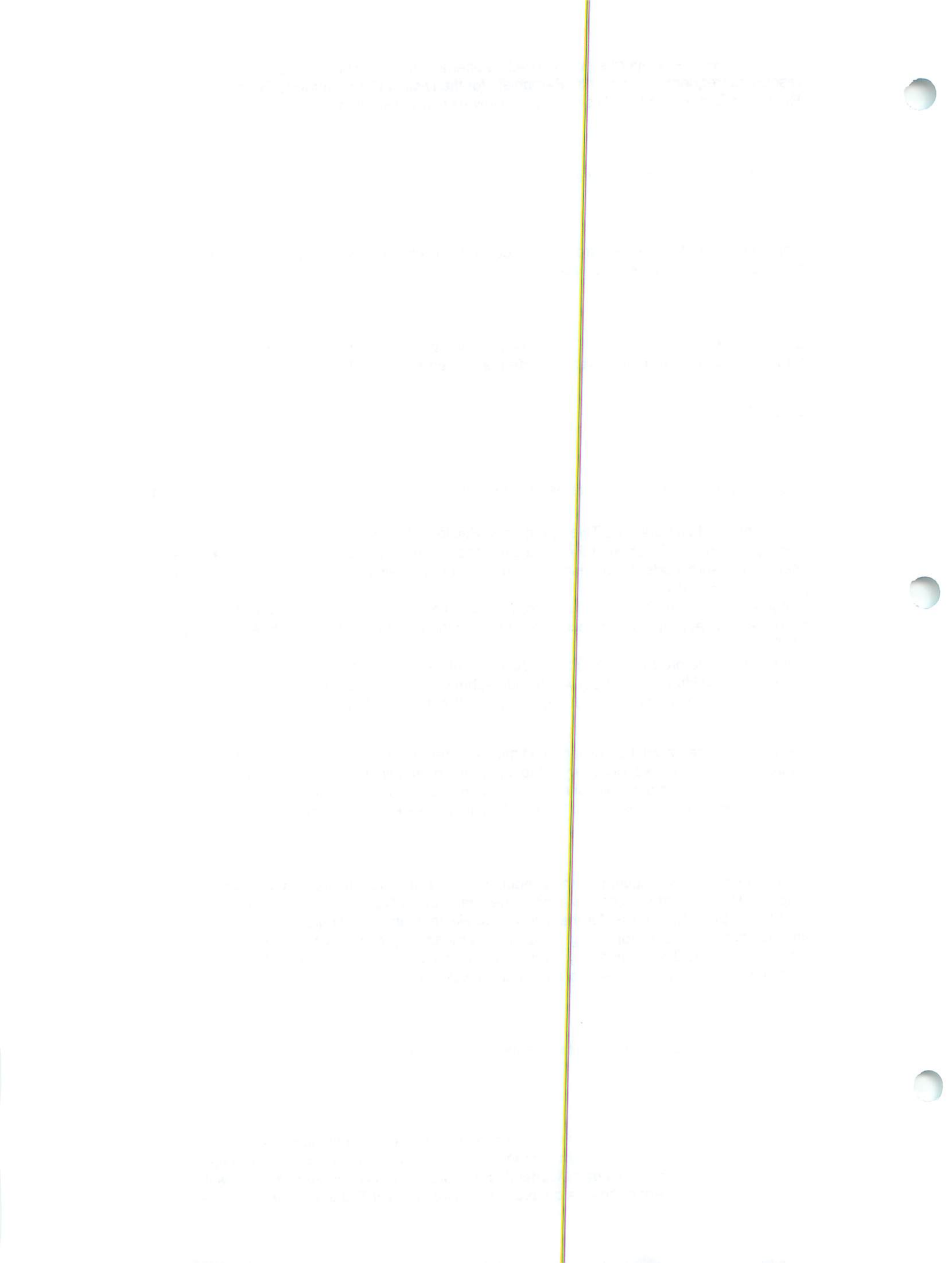

Progress Monitoring Assessments measure proficiency levels, set by the District, in grades 3-5. Additionally grade level curriculum and assessment information is distributed to parents in the school's monthly newsletter.

The proficiency goal is to move all students to a level 3 and above on the Florida State Standards Assessments.

Lake Shipp's Parent Compact is issued to each student at the beginning of the school year. The compact is an agreement among the school, parent, and child to ensure the child will meet or exceed Florida's Academic Standards. Various conference times will be available to meet parent needs via contacting the Grade Level Teacher. Parent/teacher



partnership is highly recommended. Parents are invited to join the School Advisory Council (SAC) for the 2015-2016 school year.

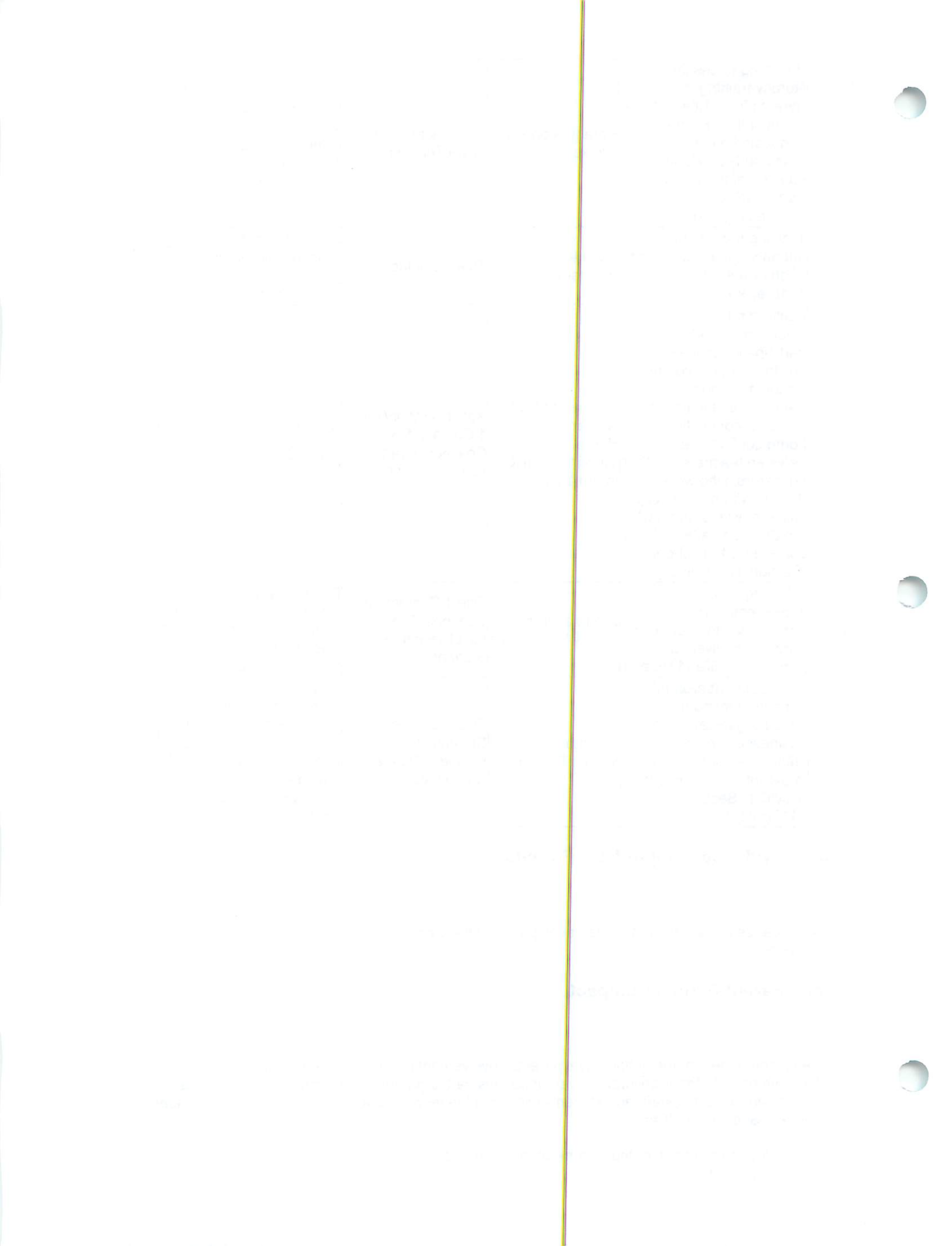
