The Parent Resource Center is always available and provides parents with literature on the many services available for Miami-Dade County Public School Students. PMP meetings, conducted via data chats, are held following district-wide assessments in order to inform parents about student progress. In addition, Student Support Team meetings are held on alternate Thursdays in order to provide increased intervention services to students who demonstrate a need for additional learning opportunities. The meetings review student progress and inform parents of any additional assistance being given to their children.
