



Response: The mission of the Columbia County School District's Title I program is to promote academic success for all students by creating opportunities and removing barriers for parents to become actively engaged in their child's education.

Response: The LEA promotes parent involvement as required in Title I Part A [Section 1118(a)(2)], [Section 1112 (c)(H)], and [Section 1112(d)(1)]. In order to meet these requirements a District Family and Community Involvement Council comprised of 45 members representing parents, teachers, administrators, private schools, and community representatives has been established. Schools place an open invitation for parents to join the District Family and Community Involvement Council and their School Advisory Council at Open House, the Annual Meetings, face to face, in newsletters, backpack, and on the web. From these names, two parent representatives from each school are elected to serve on the District Family and Community Involvement Council. All parents are encouraged to join together and communicate and provide input into the development of the District Five Year Plan, District Parent Involvement Policy, School Parent Involvement Policy and School Improvement Plan.

The District Family and Community Involvement Council meets a minimum of 3 times per year. The council provides input into the development, implementation and evaluation of all school related plans as required by LEA-wide parental involvement policy (PIP)[Section 1118(a)(2)],[Sections 1112 (c)(H), 1112(d)(1)]. Parents from the council volunteer to participate in one or more subgroups: Annual Meeting and Evaluation, School and District Parent Involvement Plan, Coordination and Integration of Strategies, and Building Capacity for Strong Parent Involvement. All parents are given the opportunity to review the District Parent Involvement Plan and offer input prior to approval. Attendance records and minutes are recorded to document the input from parents. Subgroups meet during the first and second semester. The subgroups report to the District Family and Community Involvement Council. When the council has approved the District Policy it is sent to the School Board and School Superintendent for review, approval, and adoption. The council is also involved in the review of the LEA's Five Year Plan.

The District Parent Involvement Plan is posted on the county website and copies are available in the County Parent Involvement Office. Schools post approved Parent Involvement Plans and School Improvement Plans on the web, copies are also available at meetings and upon request at the front office. Schools will hold several Parent Involvement Meetings throughout the year to accommodate parents schedule such as: different days of the week, times, childcare and serving food at meetings. All parents will receive a survey at the end of the school year seeking their input on activities, training and materials they need to help their child.

Decisions involving the use of Parent Involvement funds will be made during the development of the SIP by the School Advisory Council no later than the first nine weeks of school. Funds for parent involvement are usually spent on salaries and parent workshops to provide parents with the skills needed to support their children academically such as reading nights, math homework help, etc.

Response: The District Parent Involvement Contact provides technical assistance and other support to the Curriculum Resource Teachers at Title I schools. Meetings are scheduled monthly to discuss best practices and strategies related to parent involvement. Curriculum Resource Teachers return to the school to share information with faculty. Agendas, attendance records, and handouts are used for documentation.

School Improvement Plans will be developed at each school to incorporate parent involvement goals. This will be an ongoing process throughout the year.

Parents Right to Know information is printed in the back to school flyer supplement of the local newspaper, included in the first edition of school newsletters, on school websites, and/or in a parent brochures given out during the first nine weeks. Parents will also receive information during the first nine weeks of the school year on the interpretation and implementation of Parent Involvement Laws. Parents play an active role in the annual review of the school. Each parent is given the opportunity to complete an annual school survey.

School Level Parent Involvement Plans will be reviewed by the District Coordinator for compliance. School level CRT's will collaborate with school leadership to provide technical assistance regarding effective parent involvement strategies to be included in the school improvement plan. Opportunities will be made available for District Staff to attend local SAC meetings and/or Open House activities to present parent involvement information.

Response: The LEA will meet three times a year with the District Family and Community Involvement Council for input into the development, implementation, and evaluation of the existing Parent Involvement Plan. Council members volunteer to serve on one or more subgroup: Annual meeting and Evaluation, School and District Parent Involvement Plan, Coordination and Integration of Parent Involvement strategies, Building School and Parent's Capacity for a stronger parent involvement. Sign in sheets and Minutes are recorded to document the input from parents. Subgroups meet the first and second semester. The subgroups report to Council members at regularly scheduled council meetings.

District Family and Community Involvement Council's Annual review and evaluation subgroup reviews the District plan and practices, and revises the PIP as needed based on the information from surveys, parent participation and face to face interviews. The committee will identify barriers to parent participation and present the findings to the Family and Community Involvement Council in March/April. The findings will be documented in the minutes. This will be addressed each year with the input from parents, business, community leaders and stakeholders at the Family and Community Involvement Council. The LEA will use the findings to design strategies for more effective parent involvement.

Response: All mailings, Title I information, and district/school documents will be made available to parents in English. Other languages are available upon request. Parent

conferences and meetings will be translated as needed by bilingual staff. The District Parent Involvement Plan is posted on the District website. Each School's plan will be posted on the school's web site. If needed, American Sign Language and Braille translations can be provided for those families who would benefit from the services.

The school will have opportunities both during and after school to encourage parent involvement. Activities will be advertised on the school marquee, in the local newspaper, in the school newsletter, and through notes or flyers sent home with students. The School Messenger phone/email/text system will be used to promote family involvement activities. Parents are encouraged to utilize the school website where activities and parental resources are available electronically. Parents will have web access at each school through their parent computers available at each Title I school.

Parents are also provided regular reports of academic progress through report cards, progress reports and completed assignments. Invitations to school meetings and conferences go home by backpacks. If needed, a Response to Intervention Plan is developed and discussed with the parent. Regular RtI meetings are encouraged as follow up to the strategies outlined to check on progress. If an interpreter is required, a guidance counselor is available to assist to ensure that the needs of the parents and students are met.

ASSISTANT SUPERINTENDENT OF SCHOOLS-NARRIE SMITH	Ms. Smith shared the accreditation results. The accreditation team was very complimentary of the school district. The accreditation forced the district to look at the current practices with a microscope lens. This enabled the teams to see for themselves where improvements were needed. The accreditation team agreed and wanted us to come up with a unified plan or strategic plan for our district. Ms. Smith shared that the accreditation team compared our district with other districts around the world. The district should be very proud of the report.

In the past, schools have shared ideas and learned from each other the types of things that are super effective. Schools have even combined ideas from multiple places into one event.

FIVE POINTS-JAYNE EARLE	Five Points gave out a summer bridge book. They began by having a workshop for parents to explain the activities and give out information on prizes that could be earned. They also fed the parents after the workshop. Approximately 30 parents signed up and almost 100% turned the completed workbooks back in. They have noticed that the workbooks helped these students significantly. The summer bridge books covered all core areas as well as social studies and writing. An anonymous donor provided a table and a bicycle as prizes. Names from students that participated were placed in the drawing.

	<p>Mr. Huddleston also shared information on the district's request to change RMS to a 6th grade center.</p> <ul style="list-style-type: none"> • Goals are to protect the innocent upcoming 5th graders as they transition to 6th grade. • Eliminate 'out of zone' requests (currently at 150 LCMS and 50 RMS) • In order to pay teachers more, the district must reduce staff. This will be done through attrition. This year the district has a huge population of retirees which will make this transition easier. • District has gone from 3.5 million in the red to 2.75 million in the black. The school board had to borrow 2 million to meet payroll. The district has made many cuts. There are no more places to reduce costs. • The change will cut 1.5 million from the budget. This will help provide raises to teachers. • Even though the state increases funding, they categorize the funds which doesn't allow for salaries. • Transportation is currently funded at 40%. The district has to pick up the rest. • CCSD insurance is \$514/family per month taken out of 20 checks while next door at SCSD the insurance is \$918 per family per month taken out of 24 checks. • The district plans to expand Title I schools to all elementary schools next year. • The Robotics program has grown.
