Response: Our mission is to establish a close relationship between home and school by advancing opportunities and removing barriers for parents to become actively engaged in academics and school activities. We believe that building this relationship between home and school will assist students in developing into self-directed, lifelong learners and responsible citizens.

Response: The District Parent Task Force is composed of parents who volunteer to serve on the committee. Each Title I school is asked to locate 2 parents willing to serve. The District also distributes information about the committee in annual newsletter to all parents and asks for volunteers. Each meeting is conducted in both the morning and in the evening to accommodate parents' schedules. Childcare is provided.

- a. LEA PIP The 16-17 District Parent Task Force, composed of parents from all Title I schools, will meet mid-September to review the results of the 15-16 LEA PIP evaluation and surveys, and discuss the components of the new PIP. Their input will be used in the development of the plan. Each attending member will be given a worksheet to record their input. A draft copy will be emailed to the members of the District Parent Task Force for input in the event they are not able to attend the meeting. The worksheets and the emailed replies will serve as documentation of input.
- b. LEA Plan Sections of the LEA plan will be reviewed at each District Parent Task Force meeting and parents will be given the opportunity to provide their input. Email will be used to send drafts for approval.
- c. PI Allocation At the spring District Parent Task Force meeting, an explanation of the 1% set-aside will be given. Allocation options will be shared and the parents will be asked for their ideas. The parents will vote to determine the method to be used for allocating the funds.

Technical Assistance

Response: The LEA provides a 5.75 hr parent liaison at each Title I school to coordinate, plan, and implement effective parental involvement activities which build the capacity of parents to improve the academic achievement of their child and overall school performance.

The Title I Resource Teacher and the Title I Supervisor will conduct monthly technical assistance and support meetings for the school based Parent Liaisons and other personnel involved in the implementation of parent involvement. Requirements and the intent of the law will be discussed, as well as the sharing of best practices.

In the spring, the LEA will conduct a meeting with parents, parent liaisons, and administrators from each school to provide technical assistance in understanding the components and the intent of the law. The Title I Supervisor and the Title I Resource Teacher will review within two weeks of submission all school-level PIPs to ensure that they are in compliance with Section 1118[34 CFR 200.30(e)]. If areas are incomplete or out of compliance, the district staff will work with the school staff until compliance is met. The Title I Resource Teacher, administrative assistant, and clerk will collect documentation throughout the year to monitor implementation.

Response: The LEA will explain in the annual Title I Newsletter, to all parents, the role of the District Parent Task Force and invite all parents to participate. In addition, school

administrators will provide the names and contact information for at least two parents to serve on the District Parent Task Force. Prior to each District Parent Task Force meeting, an invitation is sent asking parents to contact the office if they have a handicap that will require accommodations. The LEA will provide accommodations to ensure participation.

The Title I Resource Teacher works with the Parent Liaison at each school site to ensure that a notebook accessible to parents is updated and maintained in the school's front office and contains all of the requirements of Title I (i.e. Principal's Attestation, SIP, PIP, SPAR, Title I Newsletter, Right To Know Letter, etc). A Family Activities Notebook (FAN) will also be maintained and will contain handouts and newsletter related to parent involvement activities. All parents are informed about the notebooks in the Title I Newsletter, schools' newsletters, at the Title I annual meetings, and at SAC meetings throughout the year to ensure that parents of new students are included.

The Title I Newsletter is used to share goals, allocations, and district strategies from the current Title I, Part A application; review the previous year's outcomes; share information about the SPAR, Principals' Highly Qualified Attestation, School-wide Plans, LEAs PIP, and website resources for assessments and curriculum.
