SAC meetings are held to collaborate with parents in order to gather timely input for improving and enhancing school programs to benefit students. Parent input will also be gathered at family events.

Parent involvement activities are developed to align with school improvement initiatives and areas of greatest need for students. These activities are offered at a variety of times, and parent input is gathered at these events in order to improve. Translations are always available for parents.

Parent involvement activities are thoughtfully planned through the Parent Involvement Committee, the Literacy and the Math Committee. Each activity provides either an activity which parents can do at home with their children, or further education as to how to help their children reach their fullest potential.

A flyer is sent home to parents in three languages informing them of the the Annual Meeting. Additionally, a caller is done in 3 languages and information is posted on the marquee. Twitter and Facebook are also used to disseminate information. On the day of the Annual Meeting, stickers are placed on the students' shirts as a reminder.

The Title I budget spending, communication strategies, School Improvement Plan summary, parent involvement activities, and parent resources will be shared during the Annual Title I meeting.

The Parent Involvement Plan (PIP) is sent home explaining the rights of parents. These items will also be further explained by the Principal and Assistant Principal. A flyer goes home to parents explaining if teachers are not state certified.

Parent meetings will be held at both morning and evening times providing parents the opportunity to attend at their convenience. Half of the monthly SAC meetings are scheduled for the morning, while half occur during the evenings.

Home visits, conducted by the administrative team and teachers, will occur as needed in order to connect with families. Translations are provided at parent events throughout the school year.

During the teacher pre-service week, a parent involvement training is provided which reviews best practices in communicating with parents and involving them in their child's education. Additionally, front office staff are provided with training in creating a welcoming school environment for parents and community members, as well as effective communication strategies.

Throughout the school year, teachers receive training on how to identify students who are struggling and creating effective Student Success Plans with parent input.

A parent library is provided in the media center to provide families with literature about parenting and supporting their children with academics. Additionally, the school counselor provides Love and Logic training for parents who are interested in learning more about positive behavior strategies.

Information about Title I Programs is provided at monthly SAC Meetings and at the Annual Title I Meeting. Additionally, a monthly calendar and flyers are sent home, and information is shared at parent involvement events.

How will your school describe and explain the curriculum at the school, the forms of assessment used to measure student progress and the achievement levels students are expected to obtain?

During the first thirty days of school, each grade level holds a parent morning and an overview of the curriculum and grade level expectations are provided. Student Led Conferences are held twice a year in order to provide a time for students to review their progress with their parents. Additionally, parent conferences are held to update parents on individual student progress. Quarterly updates are also provided to the SAC Committee which review progress toward school improvement goals.

Monthly SAC and PTO Meetings are held to inform parents about school initiatives and student progress. Student Led Conferences are held twice a year for parents to understand their child's progress, and parents are able to schedule individual conferences with teachers and administration about any concerns that arise.

Parents have the opportunity to provide feedback at monthly SAC Meetings and through parent surveys. Parents can also schedule meetings with teachers and administration.

Tutors and other bilingual school personnel are used to make information accessible to all. Phone messages and many documents are delivered in the 3 primary native languages of our community, English, Spanish, and Creole. School newsletter will have a section dedicated to Parent Involvement and Title I. This will also be printed in English, Spanish, and Creole.

To ensure that all parents have the opportunity to participate in parent involvement events, Avalon Elementary School provides activities with bilingual staff and materials. In addition, translating equipment (Talk and Listen system) is available for all events. Flyers and announcements regarding parent involvement activities are translated and distributed to all parents. Parents with disabilities are welcome to attend all activities and/or services and accommodations are made to allow them access. Event flyers include this information instructing parents to contact the Parent Involvement Coordinator if they are in need of an accommodation.
