Florida Standards Assessment scores reports are also included in each child's cumulative folder. Parents are able to request copies of those reports at any time. Score reports on local assessments will be sent home through subject area teachers upon completion of assessments and/ or on county wide progress reporting dates in combination with student grade reports.

Meetings and workshops will be offered at a variety of times and days of the week throughout the school year. SAC meetings are held throughout the school year. Parent conferences can be scheduled through the guidance office at any time during the school year. Richardson Sixth Grade Academy's Parent and Family Engagement Plan will be posted on the school's website. In publicizing events, all Parent and Family Engagement event flyers and communications that go home with students are translated into Spanish for parents whose primary language is not English. Additional language translations can be provided for those families who will benefit from the services, including American Sign Language and Braille.

The DRAFT Parent and Family Engagement Plan will also be shared in the Title I Annual Meeting at the beginning of the school year. Thorough newsletters, the annual meeting, and Social Media, parents will have an opportunity to review the plan, offer comments and suggestions.
