Response: We are conducting a variety of activities to encourage parental involvement. These will be facilitated by our volunteer coordinator and other school staff. Parents are invited to school and class events, SAC meetings, and PTO activities. Our media center is open to both students and parents. Parents may obtain a library card and check out books from the library along with their child. We partner with the St. Johns County Library System to advertise literacy events and provide activities and programs in conjunction with our school. Additionally, the Blackboard Connect system is used to remind parents of school events and our newsletter outlines events and gives tips to parents.

understanding standards, expectations and assessments. Parent conferences are held bi-annually or more often as necessary. Information is distributed by newsletter, website, written notes, phone, and planner. Progress reports and report cards go home on a regular basis. Additional communication is provided via a **parent brochure** and Mason Programs pamphlet that explains the programs and supports that our school has in place to assist families and students.
