

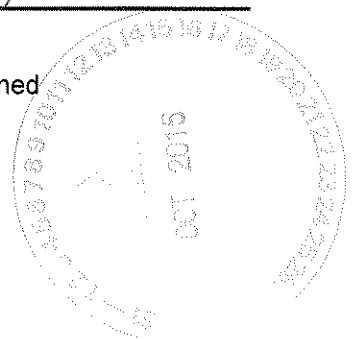

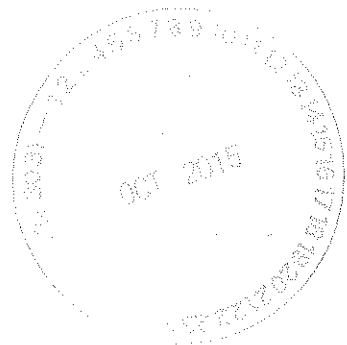

Response: At Brevard Public Schools our mission is to serve every student with excellence as the standard. We believe that family engagement is essential to fulfilling this mission. In an effort to build meaningful partnerships with schools, families and community, this district plan seeks to strengthen the relationships among stakeholders and promote collaborative planning, decision making and improvement efforts. We know that engaging our parents in the education of their children and fostering leadership

opportunities will positively impact student achievement and help ensure that we meet the needs of all students at Brevard Public Schools.

Response: Brevard Public Schools (BPS) has created a Title I District Advisory Group (DAG) composed of parents, school staff, district staff and community members representing Title I schools in the three areas of the county. All Title I schools were provided with application forms for DAG membership. Members were chosen for the committee based on various criteria on the form (e.g. gender, ethnicity, role, location in the county, parents of diverse learners - ESE, ELL, etc.), with every effort to create a committee representative of our district population. This committee provides input into the development, implementation and evaluation of the following: the district's Title I Parental Involvement Plan (PIP), the district's Title I Plan, how the 1% of Title I funds reserved for parental involvement will be used and the District Improvement and Assistance Plan (DIAP). Members of the DAG will serve as liaisons between this committee and Title I schools. Minutes from each DAG meeting will be made available to all Title I schools.

Parental involvement funds will only be spent on budget items included in the approved 2015-2016 Title I, Part A application. Budget items include: salaries and benefits for personnel designated for building the capacity of parental involvement; stipends and travel for staff involvement in parental involvement activities; consultant, translation, and printing services for parental involvement; materials and supplies to support parental involvement activities; software, subscriptions, dues, and fees to support parental involvement activities.

All BPS schools receive training and information on ways to include parents in the school improvement process (SIP) and all aspects of the school from the district's School Improvement Resource Teacher, the K-12 Parent Involvement Resource Teacher and the Title I Parental Involvement Resource Teacher. Each school is also asked to send parent representatives to Parent Ambassador Team meetings to receive training and gather information to share with other parents at their school sites. Furthermore, Title I parents are invited to participate, along with school contacts, in Title I Parent Involvement meetings twice a year to identify needs, learn new family engagement strategies, and share best practices.

The School Improvement Resource Teacher offers training for the School Advisory Committee (SAC) members at each site. Parents are encouraged to become active members of their SAC team and asked to provide meaningful input into the development of all plans related to school improvement.

The district requests all parents throughout BPS to provide feedback and input through an annual Parent Survey. The district-wide survey is available online, and in paper, in

English, Spanish and Haitian Creole. District and school results are compiled, posted on the district website, and provided to schools to share with stakeholders and use in program planning for the following year. All SAC teams utilize the results of the annual survey and evaluations from school level activities to develop goals and activities for both their Parent Involvement Plan (PIP) and School Improvement Plan (SIP).

The Title I Coordinator will ensure that a minimum of 1% of the district Title I, Part A funds are reserved for parental involvement services and at least 95% of these funds are allocated to Title I schools. Decisions involving the use of these funds will be made as the SAC team develops the PIP and SIP at each Title I school, and only include budget items included in the 2015-2016 approved Title I, Part A grant application. Parents of students in each Title I school serve as members of this team and will actively participate in this process.

Technical Assistance

Response: BPS provides the following necessary coordination, technical assistance, and other support to assist Title I, Part A schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance and to ensure compliance with all requirements of Section 1118:

* Technical assistance meetings are provided by personnel from the Office of Title I and other district offices to principals and contacts of all Title I schools to review student achievement data and assist in the development, implementation, and review of all required plans at both the district and school levels. Additionally, Title I parents are invited to participate, along with school contacts, in Title I Parent Involvement meetings twice a year to identify needs, learn new family engagement strategies, and share best practices.

* The BPS Title I Family Involvement Resource Teacher facilitates the development, implementation and annual evaluation of the BPS Parental Involvement Plan (PIP) through the District Advisory Group (DAG) and ensures that it is distributed to all participating parents under Title I Part A.

* The BPS Title I Family Involvement Resource Teacher and other district personnel provide technical assistance meetings, train-the-trainer opportunities and school visits (as necessary or requested) to assist Title I contacts, parent involvement contacts and parent leaders in disseminating information and providing in-service training to school-based personnel and parents.

* The district K-12 Parent Involvement Resource Teacher and the Title I Family Involvement Resource Teacher work collaboratively to provide district Parent Ambassador Team meetings (9/11/15, 10/9/15, 11/20/15, 2/12/16, 3/4/16, 4/8/16), parent focus groups and training opportunities for parent representatives throughout the school year on a wide variety of pertinent educational and community topics. Parent Ambassador Team representatives share the information at their schools through a designated notebook, newsletters, SAC meetings, PTO meetings, faculty meetings, etc.

* The BPS K-12 Parent Involvement Resource Teacher, Title I Family Involvement Resource Teacher, FDLRS East Staff, Student Services Resource Teachers, Title III, community organizations and parent leaders work collaboratively to plan and implement a free annual Parenting in Today's World Conference for Brevard parents. This year's event will be held on Saturday, October 10, 2015 at the BPS Educational Services Facility (School Board.)

* The BPS Title I Family Involvement Resource Teacher monitors school level compliance with all requirements of Section 1118 by: providing technical assistance training on the development, implementation and review of School PIPs with active participation of parents (review and comments will be documented through the FDOE online system and specific items to be addressed, suggestions for strengthening School PIPs and examples will be emailed or discussed in person with school contacts); providing Title I school contacts with timelines/checklists of required tasks; procedures for maintaining compliance documentation; templates and samples of school-level documentation; opportunities to share and highlight best parental involvement practices; providing train-the-trainer opportunities; providing school staff development opportunities; reviewing documentation of school-level parental involvement activities, providing feedback and conducting on-site visits to schools as necessary or requested.

Response: The district Title I Family Involvement Resource Teacher will gather and disseminate data related to the implementation of parent programs at the LEA and school levels. Brevard Public Schools will gather information and feedback regarding the content and effectiveness of this parent involvement plan (PIP) and identify needs using a variety of data, including:

- * BPS Annual Parent Survey results (district and school level)
- * Title I schools' parent and teacher feedback and/or recommendations
- * Parent Ambassador Team survey results and/or recommendations
- * Needs and recommendations gathered through Title I Parent Involvement meetings

The Title I District Advisory Group (composed of parents, school staff, district staff and community members representing Title I schools in the three areas of the county) will meet at least two times each school year to provide input into the development, implementation and evaluation of the existing district PIP. This committee will utilize the data listed above (in bullets) to evaluate the effectiveness of the plan and work with the Office of Title I to identify and address needs and strategies for addressing barriers and continually improving the program. We strongly believe that the schools should have the flexibility to personalize their programs to meet the specific needs of their school, however, a district wide survey will be utilized to obtain key information to guide planning and decision-making. Reviewing the latest data results and information will be an ongoing process for the committee. Each meeting will provide opportunities to discuss existing PIP strategies, identify additional needs and barriers to be addressed, and engage in collaborative planning. Subcommittees may be formed or other individuals/groups may be contacted to obtain additional information, research and resources between meetings and then report back to the committee in order to ensure identification of effective strategies. Annual parent survey information will be available for review each spring. Final input and recommendations for the new district PIP will be gathered at the last DAG meeting, scheduled at the end of the school year in May. Once the final document has been completed and approved by the FDOE, it will be sent to DAG members. The ongoing continuous improvement cycle process of reviewing the effectiveness of the plan activities and strategies will continue.
