#### PRESIDING OFFICER

Prior to the meeting, all members received a copy of the School Improvement Plan, Title 1 Budget, Compact, and Parent and Family Involvement Plan to review before the meeting.

- S. Claridy welcomed and called the meeting to order at 3:36p.m.
- S. Claridy reviewed the minutes, B. Johnson made a motion to accept the minutes as written, A, Campbell seconded the minutes. Minutes were approved.
- School Improvement Plan A. Hippeli Explained the School Improvement Plan (SIP) and that STAR scores is the data that is used. He explained our areas of focus this year differentiation, small group instruction, and positive culture and environment. All expenses in SIP are included in our budget.
- Student Demographics A. Campbell shared current students enrollment is 667, which is higher than we normally are at this time of year. Due to the increase in enrollment, another primary unit was added and a move from an intermediate teacher to primary occurred. Current demographics of students are as follows: 323 female, 344 male, 19.5% Black, 39% White, 37.2% Hispanic, 3.7% Multiracial, less than 1% Asian/Indian. Our demographic breakdown has stayed the same for the past few years and aligns with our SAC Committee balance. Current Enrollment numbers in each grade level, Kindergarten 114 students, 1st grade 112 students, 2nd grade 114, 3rd grade 98 students, 4th grade 109, 5th 94 students.
- Staff Vacancies A. Campbell We have two vacancies currently. An Inclusion ESE teacher that is currently filled by a sub, and an ESE Pre K teaching unit. Ms. Sykes is a long-term sub that will enable the ESE students to receive the services they need. Mrs. Campbell is still interviewing and searching for candidates for the positions.
- Title 1 Budget A. Campbell opened the floor for discussion on the Title 1 budget that was shared at the September meeting.
- Title 1 Compact and Parent and Family Engagement Plan M. Starling reviewed the documents opened the floor for discussion for any changes that needed to be made.
- S. Claridy asked for questions or concerns and if there was any new business.

#### ADJOURNMENT

With no further discussion Raylee made a motion to adjourn, Z. Marius seconded the motion and SAC adjourned at 4:01 p.m.
