Various strategies will be utilized during the 2019-2020 school year to increase parental involvement at Lincoln Park Elementary School. Meetings will be held before, during and after school. Parents will be invited to participate in our School Advisory Council (SAC) which provides them the opportunity to improve our school by sharing in the decision making and providing input. SAC meetings are held four times a year. Monthly Newsletters showcasing upcoming events and important information are provided by the principal. Flyers and School Messenger are other avenues utilized to communicate parental involvement activities with our families. Each nine weeks parents of Kindergarteners through fifth graders are invited to Report Card Day conferences. Throughout the entire school day and late afternoon, teachers scheduled individual 15 -20 minute conferences with each parent to discuss their child's academic and social progress. Additionally, parents are provided with strategies to work with their child while at home. Flexible schedule during teachers planning period allows parents to schedule their conferences around their work schedules. We have implemented APTT Academic Parent Teacher Teams (APTT) for the past two years. We will host one meeting this year as a finality of the program. APTT strengthens the parent - teacher - child academic relationship. During the meeting, parents set learning goals by using provided academic data specific to their child, and fun learning activities to use at home. We host Quarterly Family STEM Nights where the entire Family is invited to attend. It is a parental involvement activity which is well attended. Quarterly, parents actively participate with their child(ren) to use the design process to meet a STEM challenge. The Principal uses both flyers and School Messenger to communicate parental involvement information and activities. The relaxed, family friendly environment allows parents to have fun with their child in a learning environment and opportunities to get to know other parents and families. Parents are encouraged to meet with teachers before, during and after school. The principal's "Open Door" policy provides parents/guardians with unscheduled access to her. Title I funds are used to support all parental involvement activities focused upon education. At times, the principal, teachers and school social worker will make home visits to provide information regarding school related concerns. Assistance with transportation needs are provided by guiding parents through the bus accommodations process.

During these conferences student grades, formal and informal assessments, and strategies for improvement are discussed. Phone calls home and home visits occasionally occur at all grade levels. Frequent communication occurs between the parents and the school. When parents are speakers of another language, the Title I office is contacted to secure interpreters for events and for document translation. Currently, we do not have speakers of other languages. School messenger and newsletters are used regularly to inform families of school activities and information. Our school website provides easy access to our Title 1 plan, Parent and Family Engagement Plan, our school grade, dates and times of events, faculty and staff names and other pertinent information regarding our school. The principal honors an Open Door policy with unscheduled appointments are made available to provide parents with the opportunity to enjoy easily accessible meetings.
