Currently we have an MSW/LCSW intern registered with the state on staff who heads up our community
involvement partnerships. She is a huge resource and advocate for parents and students. If a parent has a need
that we currently don't have access to, she will find it. We also have a BSW who works alongside the MSW to
assist with locating resources and partnerships for assisting our families.

Building Capacity of Parents

First and foremost all interaction with parents includes something positive, even when we have the need to reach out for a behavior infraction. The core of what we do, as a school, is to build relationships with students and parents. Making sure that parents know how important they are and that we need them involved is very important. The activities we provide for parent engagement will be centered around getting to know our parents better and helping them to understand what goes on at school as well as the testing that is required for their child to participate in. Resources such as print appropriate materials; printed in the home language will be provided to parents as well as a listing of online resources parents can use at home. We will also provide parents with a retired FSA test so they understand the type of rigorous material presented on the test. Parents are also provided with a staff listing that includes Administration cell phone numbers, email addresses for all staff including the child's teacher and the phone number to the school. Currently we have several partnerships within the community: Pace Center for Girls - Reach Program, Favor House, Currie House, Pensacola Young Professionals, CAT Team (Lakeview), Safe Place, Children's Home Society, Project Connect and we provide backpacks of food for students to take home on the weekends through Perdido Bay United Methodist Church and their Feeding the Gulf Grant. We also have community partners like Attorney Aaron Watson who frequently sponsors the elementary school supply drive. These agencies and partnerships are available on parent nights, family engagement nights and our open house to provide outreach and resources to our families.
