## Analysis of the Parent Survey

### PLUS

- 85% said they know their Title I Rights
- 81% said they agree that the school offers a variety of ways to be engaged
- 80% said their child/children are comfortable asking adults on campus for help
- 73% said they agree that the school offers a variety of ways to give feedback

### DELTAS

- 19% said they prefer school-based workshops/meetings as the best way to communicate with them
- 20% said their child/children are not comfortable asking adults on campus for help
- 46% said they have participated in learning opportunities to support their child's educational needs
- 61% said Skyward Family Access was the best way to communicate with them

### INFORMATION

- 40% said they prefer weekend mornings as the best time to meet with them
- 44% said they prefer weekday afternoons as the best time to meet with them
- 80% said they would like to be contacted by phone
- 96% said they would like to be contacted by email
- 41% said they would like more information about "home activities" to do on a computer
- 46% said they would like to know how to help their children improve Reading and Math skills
- 55% said they would like to know how to help their children improve Writing skills

As a result of the parent survey conducted during the month of March, parents voiced their opinions on several different topics regarding the 2019-2020 school year. Some of the things they stated they appreciated were that most of their children feel comfortable asking adults for help. They overwhelmingly stated that they feel well informed of their Title I Rights and many agree that the school offers a variety of ways to be engaged and offer feedback. An area of concern as noted in the comment section of this survey is communication (or the lack of). Parents stated that they like being contacted via email followed by phone calls. Parents want to know how their child is doing both academically and behaviorally. A few stated that not "all teachers are putting in grades" [in Skyward] and one parent commented, "just make me aware period". The other area of concern was that they would like more information about how to help their

children improve in Reading, Math, and especially Writing. A large majority stated the need for “home activities” to do on the computer. Although we sponsored Family Engagement Opportunities, where we discussed tools to help support their child’s learning, attendance was low.

Administration will share the strengths and areas for growth that parents expressed in an attempt to help bridge the gap(s) shared by parents. We will provide our teachers with opportunities for contact logs and help them see the value in good communication with parents. We will continue to stress the importance of keeping grades in Skyward up-to-date while also encouraging its use by more parents. We will also continue to encourage students and offer programs that parents can attend (adding the addition of digital platforms) and gain insight into various aspects of our school. By carrying out this plan, we will continue to grow and improve individually, as well as, collectively, as a school.

If DHS provides family and community engagement activities that empower parents and students with knowledge about courses, testing, graduation requirements and strategies to support academic learning, specifically targeted to the families of students in the subgroups of Black, Hispanic, English Language Learners, and Students with Disabilities, then the ELA achievement will increase from 38% to 42%, math achievement will increase from 42% to 46% and each subgroup will achieve at least 41% on the federal index.

Family meetings will be scheduled in a flexible format (ex: in-person and digitally) and will meet at different times, including Saturdays. These meetings will be duplicated at different times, days, and locations, allowing for maximum family and community participation. Family meeting information will also be available (upon request) to those families who are unable to participate during face-to-face meetings, as well as, phone and email follow up. Additional strategies will be applied if they are needed to reach the maximum number possible.

Spanish translators will be available for Spanish speaking parents upon formal request or informally through our bi-lingual staff members.

If services for a Deaf/Hard of Hearing are needed, services will be requested formally from the District.

Horizon Academy at Marion Oaks, in addition to our school facility is ADA accessible. If support is needed to accommodate a disability, appropriate arrangements will be made by the school.

Messages (which includes emails and texts, as well as, voice messages) related to progress reports, report cards, upcoming school-family events will be created using clear, easy to understand language (removing academic or educational terms/acronyms whenever possible) and sent via Skylert to registered phone numbers and email addresses of our families. Additional communications will be relayed through medias such as: Twitter, site-based website, fliers, and school marquee.

For those students whose home language is not English, documents will be translated using a free, online translation service to the home language of the family.

(1) We will use a communication plan that starts approximately 30 days before any family engagement activity. The communication plan includes Twitter posts with call to action to engage families and the community. Students will be provided invitations two weeks in advance with an option to reserve spot and sign-up. Skylert will be used the Monday before any event to remind parents of upcoming events.

(2) The communication plan will include compacts, social media campaign, website, school marquee, and Skylert messaging. The communication plan will notify of upcoming events including purpose, time/date, audience, and activity.
