### Response:

Fred Wild Elementary conducts an annual Title 1 meeting each year in September, when we inform parents about Title 1 programs and how we use out Tile 1 funds. Parents are, also, given information about the opportunities that they have to participate in their child's education. Due to COVID -19, meetings will be conducted via Virtual Meeting or phone conferences.

We also hold bi-monthly SAC/PTO meetings to keep parents up-to-date and informed on this information throughout the year. At the Annual Title 1 meeting, parents are told of the opportunities they have to participate in for their child's education. In the year 2020, SAC meetings will be held Virtually due to COVID-19. At the beginning of each year, parent names are solicited for SAC during Orientation. A ballot is then sent to all parents to approve and vote for the new SAC members. Parents are encouraged to participate in SAC and PTO meetings. Discussions regarding the school budget are had during SAC meetings and decisions are made regarding Title 2 monies. After the review of the Title 1 budget, the SAC will ask for suggestions on the Parent Involvement money. Once suggestions are given, the SAC will vote on the recommendations on the Title 2 budget. Parent input is sought at each meeting and through school-wide surveys each spring. When comments, concerns or input are given, either the principal or assistant principal make notes on a copy of the agenda and comments are documented in the minutes of the meeting.

Parents are notified of the Parent Family Engagement Plan review and Home/School compact through newsletters, flyers, and backpack notifications. Progress is discussed at follow-up meetings to keep parents aware of information and continue to solicit input or recommendations at scheduled SAC/PTO meetings. The SAC committee reviews, discusses, and votes on the Parent Family Engagement Plan and the Home School Compact in the Spring 2020 for the 2020-2021 School year for final approval. Before final approval, parental input is received and reviewed at the SAC meeting. Both items were approved. Other activities that promote student achievement through parental involvement are highlighted under "Building Capacity," but include report card conference nights and science nights. Report card conference nights give parents the opportunity to spend one on one time with their child's teacher to discuss the child's achievement and how the parent can further support the child. ### Response:

The Annual Title 1 Meeting is advertised in September through flyers as well as on our school website and Facebook page. Notification of the meetings will go out on September 18th. The PowerPoint presentation is prepared by administration and discusses opportunities for students, the rights of parents and the nature of the Title 1 program. The PowerPoint also discusses School Grade Goals and Student Achievement, including curriculum that is used and achievement levels that students are expected to obtain. The Annual Title 1 Meeting will be held on September 29th. \*\*The meeting will be held Virtually due to Covid-19. The link will be provided on our school Facebook page and on parent flyers. Parents will have a sign in sheet and an agenda. Meeting minutes will be kept in the front office and on our Facebook page after the meeting.

### Response:

Fred Wild Elementary offers a variety of times for scheduled meetings. Teachers schedule conferences with parents before and after school hours. Regularly scheduled SAC/PTO meetings are held to get input from parents to determine the most convenient time. \*\*Meetings will be held Virtually and link will be put on Facebook. Report card nights are scheduled for mid-afternoon until early evening twice per year. \*\*Report Card Conferences will be held virtually during the 2020-2021 school year due to COVID. Some will be face-to-face based on the teachers and parents preference. Teachers will send link and appt times to parents via Class Dojo. Parents are invited into the classroom to review the progress of their student by the teacher or through student led conferences. Parent involvement nights are scheduled in the late afternoon and evening. Interpreters are provided for meetings. Both the school social worker and the migrant home liaison assist in going to homes to communicate with parents. During the first SAC meetings, times and dates are discussed and scheduled. If a parent cannot attend a conference, and

there is a need to schedule an appointment during the school day, the administration will make arrangements to accommodate the parent. If a parent contacts the school in advance, transportation and childcare can be provided.

### Reponse:

The Curriculum Leadership Team - led and monitored by Megan Moesching, principal, and Allisa Burke, assistant principal, meets on the second Monday of every month during the school year or more frequently as needed, to discuss school-wide data and make plans for parent engagement activities. The Leadership team develops ideas that they take back to their grade levels to continue making grade level plans. Each grade level will be represented in a Family Engagement activity. Evidence of effectiveness or completion of an activity or task will be documented by sign-in or check off sheets for attendance and comments on parental climate surveys as well as meeting notes or minutes.

### Response:

The Annual Title 1 Meeting in addition to all SAC/PTO meetings are advertised on monthly school calendars and in the school newsletter as well as on the school web site and the school's Facebook page. Meeting notifications are sent home in both English and Spanish one week in advance, and interpreters are available for meetings. Parents are kept informed about curriculum and student progress through Back to School Orientation Night, Parent Involvement events, report card nights, parent conferences, newsletters, web sites, IEP, 504, ELL and MTSS meetings. Copies of newsletters and school calendars are maintained at the school as well as documentation logs of Blackboard calls from the web site. Additionally, copies of SAC/PTO agendas, sign in sheets/minutes, and parent invitations to participate in ESE meetings are maintained at the school. Administration and front office staff work collaboratively to create materials and ensure delivery of the materials.

The school will notify parents on the first day of school through the "Right to Know" letter that parents have the right to request information on the professional qualifications of the student's classroom teachers and paraprofessionals. The school will also notify parents when their student has been assigned or has been taught for four or more consecutive weeks by a teacher who is out of field. This notification will be a "Four Week Letter" to the parents.

The school also will provide each family with an individualized student report of the child's performance on state assessments for those students taking the assessments. Copies are available for pickup through the school's front office. A Blackboard phone call is sent out from the school to make them aware results are available.

Parents/families are encouraged to make appointments with school administration to discuss school matters, which may include giving suggestions or input or expressing concerns regarding schoolwide plans. All parents are invited to join the annual Title 1 Meeting and bi-weekly SAC meetings.

### Response:

The school provides written and verbal notification of school activities in both English and Spanish through newsletters, notifications home and Blackboard Connect calls to homes in both English and Spanish. Interpreters are available for all meetings. A Migrant Programs home liaison is housed on the school campus and assists with parent notification and education. Additionally, the school contacts the district to assign an interpreter for hearing impaired parents when requested for scheduled meetings. Administration also accommodates any parents with disabilities. The meetings for Migrant/ELL parents are held at our school in October, January, and April each year by district representatives. The administration meets regularly with our ELL paraprofessional to monitor student achievement and determine if services are required for translation of any additional languages in the student/family population.
