Eligibility and Allocation

Eligibility

Eligibility for 2020-21 TSSSA will be based on 2019 school grades and meeting one of the following criteria: a school implementing a turnaround plan or a turnaround school that has improved to a C or higher and has exited turnaround status within the last two years.

The preliminary allocation is based on a per-FTE funding amount of \$500 or as provided by the General Appropriations Act. Districts are required to complete a district-level plan. In addition, school-level plans are also required. The district and school level plans must be submitted to your school board for approval by August 1. The school board approved plan is due to the Bureau of School Improvement no later than September 1.

Family and Community Partnerships

Explain how the school will establish comprehensive support services that develop family and community partnerships.

School Coordinator: Ballard Elementary is a recipient of the Schools of Hope Grant, which focuses on wrap-around services and supporting parent and community involvement. The grant has been extended to include a third year. With these funds, Ballard has hired a School of Hope Coordinator to manage the comprehensive support services.

Parent University: The school has also implemented a Parent University to increase parent engagement, enrich the family-school relationship, and provide strategies for supporting their children's education. Additionally, the school offers education classes in English for non-English speaking parents and has coordinated with several community partners to provide health education and services for families.

Academic and Character Standards

Explain the strategies the school will implement to establish clearly defined and measurable high academic and character standards.

Administrators and the school leadership team collaborate to review student data and develop common standards-based assessments to monitor student performance. Additionally, the district provides quarterly benchmark assessments focused on tested benchmarks. The data from these assessments are used to modify instruction and ensure students receive remediation and acceleration based on the assessment results. Teachers are provided additional facilitated planning time outside of the school day to develop instruction based on analysis of student data.

Through the TSSSA allocation, the following is funded:

• Facilitated Collaborative Planning: Ballard will support high academic instruction through facilitated collaborative planning sessions that align instruction to district curriculum documents and the rigor of grade level standards. These sessions will be held weekly for three hours total and will be supervised by members of the Instructional Learning Team (ILT). Student data will be at the heart of standards-based planning sessions thus contributing to increased student achievement. Funds will support the teacher's hourly rate.

• Reading Resource Teacher: A Reading Resource Teacher will be employed to deliver differentiated small group instruction for struggling students in grades K-5. Targeted students will be based on student diagnostic, formative assessments, district benchmark assessments and state assessment data. Small group instruction will include guided reading instruction using leveled text and lessons from Jan Richardson's Next Steps in Guided Reading. In grades 3-5, support will be centered around grade level standards using grade level text.

• Paraprofessional: To support this instruction, Ballard will employ a bilingual paraprofessional who will be dedicated to providing small group instruction for ESOL students not reading on grade level in grades K-5. The Paraprofessional will start the job the beginning of the 20-21 school year and job responsibilities will include supporting small groups of students to increase student achievement.

• Character Education: Lastly, to improve school climate and provide at-risk elementary students with the skills to understand and manage their emotions, we will provide support by implementing positive behavioral interventions and supports (PBIS) coupled with Growth Mindset. Educators will work to empower students and focus on the student's actions rather than fixed traits or talents. Funds will be used to purchase class sets of mentor texts such as Anh's Anger, The Sandwich Swap, and Your Fantastic Elastic. Due to COVID 19, books cannot be shared among students. Therefore, additional copies are required for the lessons. The goal is to have these materials delivered prior to the start of the school year.

Parental Involvement

Explain the strategies the school will implement to increase parental involvement and engagement in the child's education.

Ballard Elementary currently employs a Graduation Enhancement Technician to track student attendance and assist parents with the goal of improving student attendance.

Additionally, Ballard's Home School Liaison also works closely with business partners and community organizations to provide support for families. The Home School Liaison communicates with families and organizations to promote attendance at school functions and events, as well as organizes volunteers to work with students.

As a School of Hope Grant recipient, Ballard hosts family nights that focus on equipping parents with information, strategies, and materials that help to reinforce what students are learning in school. The grant initiative also affords a School Advisory Board that has met monthly to stay up-to-date with the Schools of Hope activities and parent workshops. The Board provides valuable input regarding funds utilized to support and increase parent involvement and student success.

Incentives for Instructional Personnel

Explain the strategies the school will implement to identify, recruit, retain, and reward instructional personnel.

As referenced in the **K-12 ESEA Common Program Guidance**, Recruitment, retention and reward incentives must be based on a three-year aggregate state value-added model (VAM) score. If state VAM is not available, another student growth model may be proposed. The student growth model must be fair and reliable. The LEA must submit the model demonstrating the classification and distribution of non-state VAM teacher scores for approval. Incentives can be part of a structured pay system or a Memorandum of Understanding (MOU); however, the above criteria shall apply. Incentives for attendance and non-instructional personnel are not allowable. Recruitment incentives for teachers with less than one year of experience or for hard to staff positions will be considered on a case by case basis.

Ballard Elementary recognizes the importance of attracting and retaining exceptional teachers. As a recipient of the Schools of Hope Grant, Ballard provides incentives (\$2,250.00 per teacher) to recruit and retain teachers. Ballard also provides additional non-contracted hourly pay for teachers to participate in facilitated planning after school hours to ensure students are receiving effective, rigorous standards-based instruction. Ballard coordinates with

the district to ensure all teachers are rated as effective or highly effective based on the district Teacher Evaluation plan.

Professional Development

Explain the strategies the school will implement to provide professional development that focuses on academic rigor, direct instruction, and creating high academic and character standards.

Ballard Elementary is a recipient of the School of Hope Grant. As part of the grant, Ballard hired a Schools of Hope Coordinator who also provides support for teachers to implement effective, rigorous standards-based instruction. Additionally, Ballard employs a Reading Coach who supports teachers with a number of resources. To this effort, teachers engage in weekly facilitated lesson planning with support from the Coordinator, the Reading Coach, and administrators.

• Professional Development: Through the TSSSA allocation, professional development will be provided to staff on Growth Mindset once a month for one hour for all employees. Employing this research-based approach to teaching and learning, it is expected that students will grow as a learner and develop skills linked to future success both in the classroom and beyond.

Focused Instruction

Explain the strategies the school will implement to provide focused instruction to improve student academic proficiency, which may include additional instruction time beyond the normal school day or school year.

Ballard Elementary will extend learning time by providing tutoring beyond the normal school day to support students who are not meeting grade-level standards. This tutoring will be held for nine weeks after school, one day a week, for two hours. Approximately 60 students, in grades 3, 4 and 5, will be selected based on benchmark data and formative assessments to attend sessions. Five teachers will be paid non-contracted hourly pay to provide the instruction. Two paraprofessionals, including one who is bilingual, will be hired as well (and will have alternative start times on those days) so that they can be utilized to help supervise students outside of their contracted hours. Students will be instructed using IXL. Supplemental materials such as FSA prep intensive workbooks will be purchased to support instruction. The TSSSA allocation will also support seven Promethean Boards to be housed in the 3rd, 4th and 5th grade classrooms. This technology will be used to increase student achievement and engagement both during the tutoring program and throughout the school day. Another key strategy Ballard is employing involves its robust work in Learning-Focused. Effective teachers are key to student achievement. This continuous improvement model is designed to assist systems, schools and teachers in using exemplary practices to deliver quality instruction. This quality instruction will ultimately increase learning and achievement.
