1. Peace River Elementary students with disabilities will meet the proficiency threshold of 41% or better in each designated area, eliminating TS&I status in this subgroup. 2. Peace River will attribute 20 points to increase the performance of lowest quartile in Math from 29% F to 49% C designation, and increases of two letter grades. 3. Peace River will attribute 20 points to increase the performance in Math Gains from 37% D to 57% B designation, and increase of two letter grades. 4. Peace River will attribute 36 points to increase Science proficiency in 5th grade from 43% C to 79% A designation, and increase of two letter grades. *5.
