An out of field letter is already drafted currently at our school. When a child has been assigned a teacher that is out of field or does not meet the state licensure requirements this letter with the teacher's name is sent home with the student within 4 weeks. If the child is assigned at time of enrollment the letter is given to the parent/guardian at that time.

Response:

Any results from the Florida State Assessments received prior to the last report card, will be sent home with the report card. Upon further release of the FSA student results, parents will be notified by an automated school call out, explaining that results from the Florida State Assessments will be available for pick up at the school office during the summer months. Reports that are not picked up by parents are sent the first week of school.

After the completion of local iReady and/or Performance Matters assessments, results will be sent home to all parents via backpack and/ or explained to parents during parent conferences. Student results will be presented to parents, both verbally and pictorially through a comparison graph. Strategies that parents can use at home will be discussed. Student results from all other assessments will be discussed with parents during school parent teacher conferences held throughout the school year.

Title I Meetings will be held in the morning hours and then again in the evening hours to accommodate parent schedules. We will also have volunteer orientations during mornings and evenings and orient individuals upon request at their convenience.

Guests are invited in from the community as guest readers for Celebrate Literacy Week. Guest readers include law enforcement officers, firefighters, school board members, and community leaders. Local community members participate in a program through United Way, Reading Pals, and partners volunteers with kindergarten students. The volunteers read and provide academic support for students.

Response:

Niblack Elementary provides parents/families access to a parent resource room. This resource allows parents to check out and receive materials to assist parents/families as they work with their child to improve academic success. A dedicated family engagement computer is provided for parents that is used to access online materials, resources, and student grades electronically. Multiple parent nights are provided to support families including Science/STEM Night, Literacy Night, parent/teacher conferences, Kindergarten Orientation, and Family Reading Nights. Work packets are sent home each semester to support learning during holiday breaks. Summer packets and reading logs are sent home to support learning over the summer. Families have the opportunity to visit the school 3 times over the summer to receive support and rewards for work done in the summer packet.

Communication:

Information on Title I programs will be made available to parents at Open HOUse and Annual Title I meetings which occur in the fall. The Annual Title I meeting will be held at varying times to accommodate the parent's schedule. Notification and information will be distributed in a variety of ways

However, we will make every effort to provide other languages upon request. Parent conferences and meetings will be translated if needed.
