Parental and Family Engagement Mission Statement

The Lafayette County School District has always believed parents are a child's first and most important, teacher. The District Parent and Family Engagement Program will outline ways Lafayette District will foster parent and family engagement in the education of their children. This can be accomplished by keeping them informed, equipping them with the tools and knowledge to assist their children and by offering opportunities for teachers and parent to discuss ways to help each child achieve their maximum potential.

Engagement of Parents

Lafayette High School will involve parents/families in an organized, ongoing, and timely manner, in the planning, review, and improvement of Title I programs including involvement in the decisions regarding how funds for Parent and Family Engagement will be used [Sections1118(c)(3), 1114(b)(2), and 1118(a)(2)(B)]. All parents/families have the opportunity to become involved at Lafayette High School throughout the school year. Lafayette High School offers the following activities to all parents/families: Meet Your Teacher Day/Open House, Title I Annual Meeting, Parent-Teacher Conferences, Informal Volunteer Orientation, School Advisory Council (SAC) Meetings, club/student organization meetings, and extra-curricular activities.

Information concerning time, dates and activities will be available in newsletters, take home flyers, the school's website, social media, and phone calls. Parents/families will be encouraged to join and participate in any of the above groups and have the opportunity to participate in the decision making process for Lafayette High School.

SAC is the decision-making entity of the school. Parents/families are asked to participate in a survey seeking input on activities, training and materials they need to help their child. The SAC Committee will help develop, review and discuss strategies and activities for the School Improvement Plan and for the Parent Family Engagement Plan.

Use of Parent and Family Engagement Funds will be discussed at SAC meetings and at the Annual Title 1 Meeting held no later than the first 6 weeks of school. Documentation of parent/family participation will include agendas, minutes of SAC meetings, sign-in sheets, and surveys.

Technical Assistance

The Parent and Family Engagement Coordinator will assist LHS in developing and presenting Parent and Family Engagement programs throughout the year to improve academic success of all students and overall school performance.

Parent/family input is requested at the School Advisory Council Meetings as well as Migrant, ELL and Homeless Parent/family Meetings. Parents/families provide input into the types of meetings/workshops that are beneficial to them in assisting their children and ensuring the academic success of all children. The LEA reviews all recommendations from the parents/families and ensures that all District Parent and Family Engagement Initiatives are included in the plan.

Coordination and Integration

7	LHS 6th - 12th grade	LHS students and parents/families will be invited to a meeting in coordination with Parent and Family Engagement team and other Title I program providers, to meet the Superintendent, Principal and grade level teachers. A basic outline of each grade level will be given by teachers and "meet and greet" will follow the meeting.

Annual Parent and Family Engagement Meeting

LHS will conduct an annual meeting designed to inform parents/families of participating children about the nature of the school-wide Title I program, learning gains, school choice, and the rights of parents. [Section 1118(c)(1)].

Teachers will hold parent conferences before school or evening when needed.

Communication and Accessibility

Lafayette High School informs parents/families about academic assessments used to measure student progress and the proficiency levels students are expected to meet via newsletters, letters from the principal and parent conferences. Sixth grade parents and students are invited to an orientation meeting that provides information regarding successful transition to the middle school. At the beginning of the year, parents/families are invited to Open House. Teachers meet with parents and students to provide information specific to their grade level and/or subject area. In addition, parents are provided with information regarding the Parent and Family Engagement Plan, postsecondary and career/technical opportunities, graduation requirements, middle school promotion, school clubs/organizations, community and family support organizations, Skyward training and information, and clearinghouse eligibility for student athletes. Information will be provided for parents/families about Title I at the Annual Title I Parent and Family Engagement meeting. All of this information is also available on our school website. Information about Title I is also distributed through the district composed letters sent home with students at the beginning of the school year.

A Student-Teacher-Parent Compact is discussed and signed at the beginning of school. The Compact includes the school's expectations for students, teachers, and parents. The compact is reviewed and used during the course of the year as needed. Various information is provided in school newsletters, teacher notes, district curriculum grade level expectations, parent flyers, and student data reports are sent home regularly to inform parents/families of student progress.

Student progress is monitored through district-wide progress monitoring tools, such as I-Ready and District Curriculum Assessments. Parents are informed of student progress, according to the assessments, at parent conferences. Grades are available to parents through Skyward, but progress reports are mailed home the middle of each reporting period to parents of students with a D or F in any class to inform them of their student's danger of failing. School and district websites offer information to parents/families concerning state assessments and parent trainings.
