Cape View supplies all primary students with a red communication folder and all intermediate students with a school daily planner. Teachers offer Parent/Teacher Conferences throughout the year and utilize ClassDojo and FOCUS to communicate their child's progress. We share important information through our monthly school newsletters, school website, school marquee, Blackboard Connect Messages, FOCUS, and ClassDojo.

Letters are sent home with every student that has been taught for four or more consecutive weeks by a teacher who is out of field. A copy of the letter and a list of the parents who receive the letter is kept on file as documentation for auditing purposes.

During our Annual Parent Meeting, parents will have the opportunity to visit their child's classroom virtually. At this time, teachers will provide information regarding curriculum, achievement levels, grade level expectations, assessment plans, and how parents can help their child at home. In addition, parents are encouraged to sign-up for ClassDojo if they have not done so already, and sign-up for FOCUS to monitor their child's progress throughout the school year.

In addition, school information that is sent home is translated in Spanish whenever possible. We also provide teachers with an iPad during parent-teacher conferences that may need assistance with translating.

At every workshop/event that Cape View provides to families, we collect feedback from all the participates to evaluate each family's thoughts and suggestions of the workshop/event offered. In addition, we collect sign-in sheets from all our workshops/events to calculate the number of families that participated. Lastly, at the end of the year, faculty, parents, and community members evaluate the family engagement events on our schools' frameworks to determine return on investment.
How will the needs of families be assessed to plan future events?	Results of parent surveys and exit slips are collected from families and are reviewed throughout the year by the Title I Team to determine needed changes.
What are the barriers for parents and families to attend workshops/events and how do you overcome these? (transportation, translation, etc)	Based on last year's parent survey, parents expressed that they are not able to sometimes attend workshops/events because it was not scheduled at convenient times. On this same survey, 79% of families prefer evenings (M-F) when attending a school event. To help overcome this barrier, we have scheduled most of our family workshops/events during the evening hours. In addition, we post all information / presentations from our family nights, events, and meetings to our school website and ClassDojo. We also keep a hard copy of the presentations in the front office in our parent resource binder.
How are flexible dates and times for meetings, events and/or workshops offered? (Give examples)	Cape View schedules meetings/events at varying times. For example, parent/teacher conferences can be schedule at any time convenient for the parent. Our SAC and PTO meetings are scheduled for right after school and "Family Nights" are offered in the evening hours.
