## **Eligibility**

Eligibility for 2020-21 TSSSA will be based on 2019 school grades and meeting one of the following criteria: a school implementing a turnaround plan or a turnaround school that has improved to a C or higher and has exited turnaround status within the last two years.

The preliminary allocation is based on a per-FTE funding amount of \$500 or as provided by the General Appropriations Act. Districts are required to complete a district-level plan. In addition, school-level plans are also required. The district and school level plans must be submitted to your school board for approval by August 1. The school board approved plan is due to the Bureau of School Improvement no later than September 1.

## Family and Community Partnerships

Caldwell Elementary works diligently to establish comprehensive support services that develop family and community partnerships. Monthly the School Advisory Committee and Parent/Teacher Organization (PTO) meet to provide additional support and foster community partnerships and plan for strategic support of attendance and behavior initiatives. To establish comprehensive support services that support the development of family and community partnerships, Caldwell will employ the following strategies/initiatives:

- Family Engagement Nights that have a core academic focus (funding to secure outside agencies/organizations to provide content-oriented materials/topics, materials, food, and staff assistance)
- Utilize community centers to host family nights/events
- Partner with local churches and organizations to help with small group tutoring and mentoring students
- Host specific family nights for ESOL families and families of students with ESE services provide strategies
   and resources to use at home
- Clothes Closet for students in need this initiative will potentially support the entire student body
- Build families' capacity to support students' academic progress, specifically for parents of SWDs and ELL students.
- Establish a Family Resource center and provide a supplement to a staff to serve as a Family Resource center coordinator.
- Partner with West-area Adult school to provide resources and GED programs, English classes for parents
  on
  campus, and local agencies to provide parenting workshops on topics such as discipline, socio-emotional
  well-being, family recreation, or communication.
- Educate families on grade-level expectations for rigor and what they can do at home to support learning.
- Provide translators for all parent/family events.
- Hold schoolwide evening events and workshops to help all families, with a focus on non-native English speakers and students with disabilities, navigate the school system, understand how to interpret grades,

FSA results and other data shared with students, make the link between their child's elementary school experience and their goal to be prepared for college and careers and community resources.

#### **Academic and Character Standards**

Explain the strategies the school will implement to establish clearly defined and measurable high academic and character standards.

In order to establish clearly defined and measurable high academic and character standards, Caldwell will continue to "Raise the Bar" and utilize the following strategies:

- Conduct bi-monthly grade-level data review meetings with teachers and the leadership team. Topics will focus on trends, teacher needs, SIP implementation strategies. Data review will include STAR, Smarty Ants, Science quarterlies, Freckle, I-Station, etc.
- Progress monitoring data from STAR, IStation and Formative Assessments will be used to drive instruction with the classrooms
- Weekly collaborative planning will provide teachers time to work together in teams to review formative assessment data in math and reading with the coaches and interventionists to plan for differentiated instruction.
- The focus of PLCs will be learning targets, success criteria, target-task alignment, and student work samples.
- Continue to coach to proficiency for both students and staff
- To maintain high expectations for the successful conditions for learning, Positive Interventions and Support system (PBIS) will be used to decrease problem behaviors, increase academic performance, increase safety and establish a positive school culture. A tiered system of positive rewards has been established and shared with all stakeholders.
- The guidance counselor will implement the Stanford Harmony learning program to assist with character training and empower students to communicate, cooperate, connect, embrace diversity, and resolve conflict.
- Students and staff will engage in regular Data Chats. Building subs and/or support staff will be used to assist with student data chats. Teachers and students will work together to set academic goals to increase student motivation and academic performance.
- Utilize a tool to monitoring student progression towards instructional standards, learning targets, and success criteria.
- To effectively utilize data points to drive instruction, job-embedded professional development will be provided to all staff members through after-school and Saturday professional learning opportunities.
- -Providing strategic tiered intervention support academically and behaviorally

#### Parental Involvement

Explain the strategies the school will implement to increase parental involvement and engagement in the child's education.

To increase parental involvement and engagement at Caldwell Elementary, we will utilize the following strategies:

- Host 3- 4 student-led portfolio conference nights (Purchase books, candy, self-help guides, pencils, t-shirts and/or learning games for attendance \$500)
- Include data sheets within agendas so parents can monitor student progress within data sheets include a brief summary of what the results mean
- Utilize Social Media to promote communication home with parents
- Student-created/written school newsletter
- -A partnership with East Area Adult school will be established to provide resources to parents GED, Job Programs, etc
- Sponsor monthly parent lunches/events around empowerment topics/themes higher education, finances, health care, ADD/behaviors, etc.
- Provide a supplement to our current ESOL paraprofessional to serve as an evening parent liaison to coordinate and plan events, luncheons, translator, etc (\$2500)
- Host academic award ceremonies Scholars' Dinner students earning level 3 or higher are recognized with dinner and medallion. (Medallions \$600, Programs \$50)
- -To provide parents with a smooth process during the initial introduction of their child's teacher, Student Orientation Postcards will be ordered and mailed to parents prior to the actual day of Orientation. (Postcards \$100, Postage \$225)
- To increase family involvement, students and parents starting Caldwell after the first day will be provided a special orientation meeting/video of school policies/guidelines, mission/vision statement, and attendance agreement. A video highlighting the academic programs, before/after school clubs, as well as the attendance policy and PBIS programs. Parents new to Caldwell will be required to view the video. (TV monitor \$1500)
- Monthly family communication newsletters \$1,000-printing costs
- Use home visits to target hard-to-reach families.
- Providing Transportation to community events when needed. (\$2,000)
- -4 laptop computers will be purchased for parent use and housed in the Parent Resource Room. Parents may use this technology to apply for services, financial assistance, employment applications, etc.

#### Incentives for Instructional Personnel

Explain the strategies the school will implement to identify, recruit, retain, and reward instructional personnel.

As referenced in the **K-12 ESEA Common Program Guidance**, Recruitment, retention and reward incentives must be based on a three-year aggregate state value-added model (VAM) score. If state VAM is not available, another student growth model may be proposed. The student growth model must be fair and reliable. The LEA must submit the model demonstrating the classification and distribution of non-state VAM teacher scores for approval. Incentives can be part of a structured pay system or a Memorandum of Understanding (MOU); however, the above criteria shall apply. Incentives for attendance and non-instructional personnel are not allowable. Recruitment incentives for teachers with less than one year of experience or for hard to staff positions will be considered on a case by case basis.

The following strategies will be used to recruit, retain, and reward instructional personnel:

- To help retain new teachers, each new teacher will be "assigned" to a member of the leadership team that will provide instructional and emotional support.
- -The principal will conduct monthly afterschool "Chat & Chew" sessions with all new teachers and teachers new to Caldwell.
- Each teacher will be assigned to a House to foster a sense of belonging.
- To help retain teachers, Caldwell will provide instructional support for new and veteran teachers.
- Teachers will be awards through the sunshine committee, Teacher Appreciation week, community sponsors, and annual staff BBQ sponsored by the administrators.
- Teacher/Staff recognition will be implemented multiple times throughout the school year. Such as "Symbol of Awesomeness", "Support Staff Spotlight" and birthdays.

Caldwell will defer to the district office to provide the protocol and guidelines for monetary rewards.

## **Professional Development**

Explain the strategies the school will implement to provide professional development that focuses on academic rigor, direct instruction, and creating high academic and character standards.

Caldwell Elementary will focus heavily on professional development and coaching for teachers to ensure that they use evidence-based best practices to consistently provide instruction to students that promote higher-order thinking and pushes students to meet grade-level standards. This will be accomplished by creating integrated teaming structures for collective inquiry. The school will utilize teaming structures that provide vertical and horizontal alignment of instructional practices and strategies, including job-embedded professional development. Within the teaming structures, the following strategies will be developed collectively:

- Refining lessons in reading, math, and science that are aligned with the Florida Standards through lesson studies and unit planning.
- Providing professional development on implementing effective and rigorous instructional practices and strategies in Tiers I, II, and III; and holding teachers accountable for using the evidence-based practices they learn through PD in their classroom, including strategies for differentiating and small-group instruction for all students based on their individual needs.

- Further developing our K-2 literacy program to address literacy development and employ rigorous tasks that are standards-aligned.
- Engaging in specific planning, such as interdisciplinary and vertical planning to develop and align curriculum, instructional strategies, and close gaps.
- -Analyze data and formally assessing student work to gauge the effectiveness of strategies, to adjust instruction as needed and engage support staff and interventionist where needed.
- Share instructional tools and resources.
- During the school year, after-school and Saturday professional learning sessions will be offered. Topics will address gaps based on progress monitoring data, academic enrichment needs, and will be adjusted based on feedback, data collection from daily classroom walk-throughs and/or instructional reviews.
- Full implementation of BBY What's My Place, What's My Value Grades K-5 The teach and reinforce number literacy. Libby Pollard will be contracted to conduct professional development for the teachers that are new to Caldwell and a refresher for veteran teachers. Substitutes will be used to cover classes while teachers attend. Additional materials/kits will be purchased for new teachers and replacement pieces for teachers that have kits. -\$1,800 per session for two sessions Fall/Spring; WMP?WMV? materials/kits -\$700; Substitutes \$1000)
- Implementation of Lucy Calkins Writing Strategies (after-school training for teachers will be needed)
- Book Study with staff Teaching and Engaging Students with Poverty in Mind, Academic Teaming, and TDQ Text-Dependent Questions.
- Implementing Close Reading Strategies and the Gradual Release Model.
- SIPPS reading program professional development will be provided for all 1st-grade teachers. This reading intervention program will be purchased to support all incoming 1st-grade students due to the missed instruction in the 2019-2020 school year. The SIPPS program provides a structured literacy approach to foundational skills instruction through explicit instructional routines focused on phonological awareness, spelling-sounds, and sight words, with immediate application to reading connected text and to spelling.
- Reading interventionist will use LLI Leveled Literacy Intervention for upper grades students to provide reading support and fill-in gaps.
- Curriculum/Collaborative planning and professional development sessions with school-based and district personnel for tested content areas of ELA, Math, and Science teachers per semester for a day.
- 8 Teachers will attend the FCTM Conference in 2021. Held in Orlando Florida. These teachers will provide training to their peers.

#### **Focused Instruction**

Explain the strategies the school will implement to provide focused instruction to improve student academic proficiency, which may include additional instruction time beyond the normal school day or school year.

Caldwell will implement the following strategies to provide focused instruction to increase student academic proficiency:

- ELL and SWD will receive specialized before/after school or Saturday tutoring in reading and/or math.
- Additional tutoring opportunities (before or after school) will be provided throughout the school year in math, reading, and science to meet the needs of target subgroups
- Extended Learning/enrichment opportunities will be provided to our level 4s and 5 students in 5th grade through a math club (Tivits)
- Purchase Two book vending machines school-wide reading incentive based on the 2018-2019 FSA data and 2018-2019 STAR/STAR Early Literacy data. Students will earn tokens to use for the machines. Machines will be stocked with appropriate grade-level text for each as well as culturally/intellectually diverse books.
- Create an AR reading club to promote reading/tokens that will be provided to be used with the reading vending machines.
- Small group tutoring Title 1 Support Paras
- K-2 Reading Interventionist will provide small group instruction through the use of SIPPS and based on progress monitoring data.
- 3-5 Reading Interventionist will utilize Leveled Literacy Intervention: Students identified as reading below grade level receive instruction with the research-based program, Leveled Literacy Intervention (LLI) on a daily basis. LLI is a scripted intensive intervention program delivered in small group settings (5-6 students). LLI provides explicit instruction in phonics and phonemic awareness, comprehension, vocabulary, fluency, and writing. Students are assessed using the Benchmark Assessment System (BAS) to determine appropriate placement in the program and Florida Ready materials to provide interventions.
- ESE scheduling to maximize the Inclusion and Resource Model
- Math Interventionist will use Florida Reading materials to provide interventions and support math standards.
- Re-purposing the MTSS Team to meet regularly with teachers to monitor and discuss student progress within interventions and determine appropriate actions/next steps
- 4th and 5th Grade students will participate in an afterschool Science Club to promote additional hands-on science activities through Jason Learning Project and science standards.)
- Kindergarten and 1st-grade teachers will use leveled readers to differentiate instruction SIPPS.
- Purchase two additional iPad carts and 40 lpads (40 iPads to be used in the science lab and with after school tutoring. This technology will also be used in the classroom to develop skills essential for the 21st-century learner. Students will utilize virtual platforms for instructional tasks and for collaboration and academic teaming in the classroom and during distance learning.
- Purchase Nearpod Subscription to use with Ipads to support student learning and implement technology use within the classroom and/or distance learning.

The items above were based upon improving the 18-19 science proficiency scores of 30%.

- Based on our overall math proficiency of 47%, we would like to continue to fund a math interventionist and employee one building substitute through Kelly Staffing to work with the students in small groups under the

direction of our math interventionist. In addition, Origo Education Book and Box of Math Fact kits will be purchase for each teacher to increase math fact fluency in addition, subtraction, multiplication, and division. We will also purchase math rack for K-5 classrooms as well as Think Tank kits to support math instruction in the areas of Fractions, decimals, problem-solving.

- Based upon our reading proficiency scores of 44%, we would like to one building substitute through Kelly Staffing to work with our reading interventionists to assist with small group instruction.
- -Purchase classroom libraries of non-fiction texts for K-5 classrooms to help increase reading and science proficiencies.
- -Purchase school-wide BrainPop subscription(s) to assist all students with higher-order thinking skills to increase student achievement among our ELL and ESE students as well as provide differentiated instruction for our accelerated students.
- -Purchase Elementary Mini-Q for 4th and 5th grade to support content-based reading and writing using document-based questions as a method of instruction.
- -Two additional para-professionals will be used for math and reading remediation skills during small group instruction and/or classroom lunchtimes to maximize instructional times to close achievement gaps.
