Response: Myrtle Grove school will involve parents through various avenues that will allow parents input into their child's and the school's educational journey towards success. School Advisory Council meetings (SAC) and communication from teachers and school administration are a few methods used at Myrtle Grove. Parents receive notification of all programs, meetings and activites in the form of newsletters, phone calls, flyers, parent/teacher conferences, marquee, school web page and the "School Messenger" which calls homes to give updates. These notification methods allow parents the opportunity to be aware of programs offered at the school, such as: after school tutoring, parent meetings, and Parent/Child Literacy Nights. Parents receive notification regarding student progress through frequent phone calls, student progress reports, report cards, teacher conferences, classroom newsletters and report cards. There is a shared home school connection that gives parents the tools to extend learning to the home by providing resources such as FCAT Explorer, FOCUS, Reading Eggs, and Study Island to support student learning in the home environment. A volunteer program is available for parents interested in supporting the school. Signs are posted in different locations promoting volunteerism. A volunteer coordinator is always available to ensure all volunteers are treated with respect, have answers to questions and placed in a comfortable location. A parent resource room has been established to ensure that parents have access to technology, curriculum, materials, teachers, and media services in a timely manner. A parent liaison has been hired to manage the resource room to ensure that this happens. Parents have a part in the decision making process through the School Advisory Council which meets 4-8 times a year. The Advisory Council members assist in evaluating, implementing, and developing policies for the school. Parents can provide input regarding budgets, and have the opportunity to discuss and give ideas on how Title 1 funds will be spent. After the budget is developed, parents, through SAC, review and approve it. All School Advisory Council meetings are open to the public. Parents represent a cross-section of the school's population taking into account grade levels, ethnic/racial backgrounds, parents of students with disabilities and parents with limited proficiency in English. Parent input is documented by surveys, minutes, and comments. Parents are also allowed to select their child's teacher for the upcoming school year by sending in a "parent request letter."

The Parent Resource Center builds strong family-school-community partnerships in both regular and special education. Parent educator provides workshops for parents to increase their knowledge and skills to empower them to interact proactively with the school and their child's educational program. Workshops are offered based on the results of parent surveys. A lending library is available with videos, books, discipline strategies, technologies and other materials to enrich parenting skills.

Conferences, meetings and activities will be available during school and after school hours.

Information will be in a language that is understandable, to the extent that is feasible. Myrtle Grove Elementary uses "School Messenger" as a vehicle to disseminate information regarding events and activities at the school. The School Messenger phone system allows Myrtle Grove to have the ability to dispense concise, on-time messaging to notify parents, within minutes, from any location. We provide interpreters for parents speaking other languages as well as deaf parents.

The School Advisory Council allows parents the opportunity to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children. The School Advisory Council is required to meet four (4) times a year. Myrtle Grove meets at least four times to allow parents the opportunity to be apart of every aspect of their child's education.

Regarding the "Parents' Right to Know" provisions in the law, a letter is sent out with information on the child's level of achievement on state assessments, along with a timely notice that the child has been assigned to or has been taught by a teacher who does not meet the highly qualified teacher requirements for four or more consecutive weeks. All teachers at Myrtle Grove are highly qualified.
