Weis Elementary also holds family nights such as talent show, winter program, open house, and family dinner nights. We are also fortunate to have a call out telephone system (School Messenger) we use to inform parents of school events and news. The School Advisory Council also plans and reviews and helps make decisions about our school's budget, academics and overall progress of our students.
