**Response:** At BCES we are available and willing to assist parents in any way necessary. Staff in the front office are available to assist parents when completing OASIS volunteer applications and assisting in parent/teacher communication.

Boggy Creek Elementary is also embarking on the AVID program for all of our students. With this framework we will encourage and support parents by inviting them to attend AVID Nights and Academic Future Readiness Nights.

Parents are also invited throughout the school year to the Media Center for computer assistance with lunch and volunteer applications.

The Title I Mobile Lab is available on the 2nd and 4th Thursday (12-2)of each month. Parents can request and borrow three supplemental educational items per child for a two week period to use at home. Parents will be able to work with their Parent Resource Center Liaison to place an order. The best part is that the educational materials will be dropped off and picked up right at your school for your convenience!

All parent events will be announced through but not limited to, flyers, out-dial calls, website, newsletters, etc. along with maintaining sign-in sheets. Communication will be sent home in English, Spanish and any other language will be translated for parents to fully understand our communication.

When each grade level hosts their "grade level night" during the first 6 weeks of school, parents will be informed and provided information about accessing their child's grades through the parent portal/FOCUS.

During each Grade Level Night, teachers will provide parents with additional instructional information about the subjects they teach, the assessments, and how parents can help at home. The same information will be provided in a packet distributed to any parents who are unable to attend.

At the annual Title I Parent Meeting, information will be provided to the parents about the Title I programs, the curriculum, and academic assessments. Sign-in sheets for the meetings will be maintained in the Title I box and uploaded to the share-point for monitoring purposes. Information about Title I programs is distributed through the district composed letters that are sent home at the beginning of the year, this information is also available on the school website and front office. Also sent home at the beginning of the year is the Parent Compact. The Parent Compact is also reviewed at a parent conference during the course of the year. Other mediums of communication that Boggy Creek Elementary uses include school and district websites, parent meetings and conferences, school newsletters, parent flyers, student data reports sent home quarterly to inform parents of student progress. Student progress is monitored through progress reports, quarterly report cards and Progress Monitoring Plans. In addition, parents receive reports regarding their child's assessment results on the STAR and other district, state and local standards based assessments as they are completed throughout the year.

The Title I booklets and district PIP were sent home in the Welcome Back packets. Every new student who is registered at BCES also receives a copy.

Curriculum being used at BCES is addressed at the school SAC and PTO meetings. Also, what is being used specifically in the 3-5 grade classrooms is reviewed at Grade Level Nights. Technology Links are available directly the BCES website for parent access. Immediate access into student grades is available through FOCUS, located on the BCES website.

Any parent is able to request a parent/teacher conference and must give at least 24 hour preparation time for the teacher. Both in person and telephone conferences are available.

Parents may contact teachers via email addresses. All teacher email addresses are available on the BCES website. Any parent is able to request a parent/teacher conference and must give at least 24 hour preparation time for the teacher. Both in person and telephone conferences are available.

All students have a school agenda. Teachers use these to communicate daily with parents in regards to both student work and behaviors.

It also allows monthly updates on the administrative side of school issues from curriculum to testing to behaviors and even great achievements by students and staff.

via emails to ensure all information is sent to students on a regular basis.

School Newsletters go home every month to every student (English/Spanish copies).

Boggy Creek's website (main page) is consistently updated with current events.

Teachers send home either a monthly or weekly calendar with the students in order to send home information on events at school as well as within their classrooms.

Osceola County School District has a virtual backpack website that parents can visit in order to see the various community businesses that are involved with the various schools.

Boggy Creek's front marquee, located in the front of the school, is updated with various times and dates of important events.

The Multi-Educational Department at the district office provides translated materials to parents. The front office has handout materials supplied. When applicable the district special needs staff are available to assist parents with mobility concerns and with sight and hearing disabilities.

The school PIP will be summarized and a copy of the summary will be sent home to all parents. The PIP will be posted on the schools website in its entirety.

At Boggy Creek we have a high transient/mobile population. Our goal is to make sure that each student and parent that enrolls with us receives the same Title I information that was given to all students and parents during the first week of school. Every parent who enrolls their child at Boggy Creek Elementary will be provided with a packet that contains our School and District Parent Involvement Plan, informational Title I Booklet, a BCES School Compact, and a BCES PIP Brochure.
