\*PTO Meetings - Parents have the opportunity to participate in these monthly meetings where information is provided about activities that are occurring on campus and ways that parents can become more involved at the school. PTO meetings also provide opportunities for parents to receive information and strategies on how to help their students at home with academics.

\*Fall Festival- PTO will sponsor a fall festival partnered with community and business members along with parents. The event invites families into the school to participate in fun activities and will foster a positive school to home connection.

\*Book Fairs- The Media Specialist will host Book Fairs for students, parents and teachers to attend. Each Book Fair will include an after hours event for parents and students.

\*Parent Conferences/Parent-School Compact- Each parent will be required to attend a parentteacher conference at the end of the 1st nine weeks and at the end of January to discuss their child's academic progress. The information provided includes: the Florida State Standards, the classroom curriculum, assessments, school and classroom expectations, how parents can help at home, how parents can communicate with the teacher and schedule a conference, and opportunities for participation in decisions related to the education of their child.

At the Annual Title I Parent Meeting, information will be provided for parents about Title I, Title II, Title VI, and SIG, our curriculum, academic assessments, and grade level expectations. All of this information is available in the Title I Notebook in the Front Office and on our school website. Information about Title I is also distributed through the district composed letters sent

home with students at the beginning of the school year.

A Student-Teacher-Parent Compact is discussed and signed at the beginning of school. The Compact includes the school's expectations for students, teachers, and parents. The compact is reviewed and used during the course of the school year.

Various Title I information is provided in school newsletters. Teacher notes, district curriculum grade level expectations, parent flyers, and student data reports are sent home regularly to inform parents of student progress.

Student progress is monitored through district-wide progress monitoring tools, such as Performance Matters and STAR. Parents are informed of student progress, according to the assessments, at parent conferences. Parent reports are also sent home after each assessment is administered.

Progress reports are sent home the middle of each reporting period. Report cards are sent home at the end of each nine weeks grading period to inform parents of the student's classroom grades, conduct, and work habits.

School and district websites offer information to parents concerning state assessments, parent trainings, in addition to providing resources for parents wanting to assist their children at home.
