Response: The success of our team for the past several years indicated it was important to have continuity. Three parents along with several staff members have remained on the team and new members have been added. Our Family Involvement Planning Team (FIPT) includes four parents, five teachers, a paraprofessional, the school counselor, and an administrator. In May, 2015, the team attended a district Title I training covering the following topics: six types of involvement and their benefits, reviewing 14-15 PIP strategies, celebrating successes, district PIP review, strategies for working with ELL families, using data sources for developing new strategies, funds availability and usage, reviewing the Starting Points Inventory and time for action plan development. Barriers, research-based best practices, current data and 14-15 plan review/evaluation were used to develop goals and strategies for 15-16 school year. The FIPT will meet monthly to review, revise and evaluate plan strategies. The FIPT will garner support from stakeholders to implement strategies. In the fall the SAC will review the FIP and offer suggestions. The FIPT will then approve the FIP. As members leave the committee they will be replaced and new members trained.

Monthly workshops for parents through the iMom/All Pro Dad organization, hosted by school parents to increase parent skills and parent/child communication.
