I Ready will be used to enhance students' reading comprehension skill, and parents will be notified of this via a letter. Youth Co-Op also distributes to parents who attend the FSA Parent Night home with practice materials to keep and use at their discretion. The school's website stores links to programs and resources for parents, as well.
