Home visits will be conducted on an as needed basis by our guidance counselors, ESOL coordinator, ESE coordinator, School Resource Officers, administrators, and teachers. Alliances with our feeder schools will be established to merge our parent meetings. Parent meetings will also be held at various locations throughout the year ie. Palm Beach College, Lake Worth Municipal Library, John Prince park, etc., to allow for exposure to the various areas within the community.

Prior month's evaluation is used to developed the trainings for the following month. Organized by Hansje Laguerre, parent liaison. Depending on the presentations, presentors will vary. Evaluations are used to review if the training was beneficial. Trainings are provided monthly. Parents will be encouraged to attend sporting events along with club sponsored activities and cultural events. Parent volunteers, cleared by District will assist with SAC, mentoring, business partnerships, and after school activities. These events will enable parents and students to work collaboratively toward academic goals as their schedule permits. Student agendas are provided to the students as a means of daily communication with parents. Edline is updated bi-weekly to ensure the continued academic growth of the student.

Parent resource center. It is available from 7:30 to 9:00 Monday through Thursday and 7:30 to 5:00 Friday. Resource center is operated by parent liaison: Nadilia Charles. Resources have been provided for parents on scholarships, test taking strategies, homework help, etc. Computers are available for parents to access edline etc. Parents are requested to sign in when utilizing the parent resource center. Monthly review of the sign in sheet will determine how often it is used. Parents are also asked to write down comments/suggestions for the resource center on the sign in sheet. This is also reviewed monthly to make changes to better meet the needs of the parents. Technology support is also provided to assist parents in completing the on-line FREE and Reduced lunch applications along with tracking the student bus rounting information.

Response: All communication (printed and spoken announcements) is translated and distributed in English, Spanish and Creole. Some examples of parent communication include: Agenda books, Parent/Teacher Conference Thursdays, develop Parent Policy Plan and Compact jointly with parents, flyers, letters home, announcements on the marquee, auto dial call-outs, local radio stations, web site announcements, edline, school web page, standing parent-teacher conferences for every Thursday afternoon. Invitations to attend any school related activities are sent 1-2 weeks along with call-outs and reminder phone calls. Grades are posted through Edline bi-weekly, State and District Assessments are shared at the SAC meetings, one-voice to parents in different languages, information is published in our newsletters and progress/report cards are sent home in the students' backpack. An email system along with a Facebook/Twitter system will be established as an additional means of communication.

Response: Community Language Facilitators (CLF) are available at group functions and events for translation in Spanish and Creole. Bilingual student aids are assigned to teachers with a high percentage of students that speak their native language to provide assistance. All communications that are distributed in writing and through the auto-dialer are printed and recorded in multiple languages, the local Haitian and Hispanic radio station cooperates with LWHS to disseminate school information and promote events, Guidance Counselors include fluent speakers of other language to assist with parent concerns. The school is equipped for handicapped accessibility. The ESE department conducts IEP meetings as a means to reevaluate their students status in the program. Students in the migrant programs along with their families are provided support through their home visits, individual counseling and tutorial services. Meeting will be held in centralized locations for parents with limited mobility and/or other disabilities.
