The Parent Teacher Association is another governing board which focuses on school-based events and activities in which parent volunteers are needed to facilitate to ensure success. Such events include the annual Country Fair and Chili Cook-Off, Red Ribbon Celebrate Success Day and the Super Seller Picnic. Parental input is sought, recognized, valued and strongly considered in the decision making process, including decisions involving Title I programs and funding available. In addition, parental feedback is solicited via the annual school climate survey as well as at each parental involvement activity hosted by the school.
