Our Family School Liaison will coordinate the implementation of parent education programs such as Readers of the Caribbean (Grades K-2), 5th Grade Family Fun Night, 2 separate Science Nights (Grades 3-8), and Math Night (Grades K-5). The Family School Liaison will also work with teachers and parents to supply supplemental educational materials and technology hardware to students whom teachers identify as needing remedial assistance.

A bilingual parent volunteer and a staff member make telephone calls and translate teacher notes to parents. These translators are also on hand on parent conference nights and during LEP and ESE meetings to ensure that parents are able to fully participate in these meetings.
