Response: Class schedules and an opportunity to complete an On-line Free/Reduced Lunch application are provided to students and parents at our orientation in August. Title I program information and course syllabi is provided at our Open House which occurred August 24, 2015 and during the first week of classes.

At the orientation, parents and students are free to walk about the campus after having retrieved their child's schedule in the guidance office. They also have access to several booths and displays in the courtyard which provide information about: resources, supports, services, clubs, and activities to support their child's success.

At Open House in August, Parents and students are directed to the auditorium to attend the Annual Title I meeting. At this time, the "Parent's Right to Know" booklet and "The First Teachers" brochure are available in the event the child did not take the information home during the first week of school. At the conclusion of this meeting, parents are given the opportunity to meet and speak with their child's teachers and are provided the course syllabi if the parent has not received one or request an additional copy. During the first week of classes, the students receive their syllabi and are asked to take them home, review them with their parents, and return signed to the teacher for extra class credits.

Response: At all parent events, embassy style translation systems are in use. Parents can listen in Spanish or Creole. All school information is sent home in the student's native language as well as English. An auto dialer is also generated in three languages informing parents that information has been sent home by students.

Handicap access is guaranteed as all of our meeting rooms are on the ground level. In a case where it would be necessary to meet in the media center on the second floor, the elevator would be made accessible through use of a key by staff.

Translators are used at parent conferences, student led conferences, and IEPs to insure parents, teachers, administrators, and staff comprehends and works together towards student success.

Weekly announcements through School Messenger (phone dialer system) is provided by the school principal in English, Spanish and Creole to inform parents of upcoming events such as SAC meetings, Open House, upcoming events and special recognitions.
