Fox Chapel Middle School's parents are involved in the planning, review, and improvement of the school's Title I Parent Involvement Plan, School Improvement Plan, and Title I school-wide programs. FCMS holds a monthly Title I Committee meeting and all parents are invited to become members. The committee is made up of staff and parents. We encourage parent participation and use the following methods to inform our parents and guardians: notices sent home, school website, automated phone calls, and personal calls (to parents responding to parent surveys conducted during Open House held prior to the start of the students' school year and information gathering notices are sent home the first week of school). At our Title I Committee meetings facilitated by the School Improvement Facilitator, parents are involved with reviewing our progress on the school improvement goals, approving the Title I budget for FCMS, and planning Title I activities (such as one of our parent involvement activities, student-led conferencing) designed to improve student performance in Reading, Writing, Science and Math. The content areas covered during these meetings include: the Parent Institute, and the Midyear Report, revision of the Title I Parent Involvement Plan and Compact, and Parent Surveys.

Parents are also invited to become a member of the FCMS's Family Involvement Team. Teachers and other school level educators nominate parents to represent our school and our principal selects the parents to become members of FIT. One of the most important tasks FIT members are responsible for is encouraging other parents at our school to become actively involved in leadership committees such as our School Advisory Council (SAC) and Parent-Teacher-Student Association (PTSA).

FCMS has a Parent Educator who keeps our families informed of all activities including FIT and Title I Committee meetings and Parent Nights featuring workshops such as Cyber Safety, Gang Awareness, Bully Prevention and use of Edline, which is an online program that provides parents with weekly progress checks on grades, homework, and projects. 1% of our Title I funds are used to hire our Parent Educator who is responsible for managing our Family Center and building an effective parent involvement program at Fox Chapel. The School Improvement Facilitator along with the Parent Educator manages parent involvement practices and activities at FCMS.
