Information is shared on student progress and achievement reports which are initialed by teachers and parents daily and monitored weekly. Interim reports are sent home every four weeks with report cards issued every nine weeks. Conferences are held as necessary throughout the year. SJTHS will also use Parent Assistant as part of the eSP data management program.
