At these meeting, the Dress for Success Plan, the PBS/Discipline Plan, and scheduling/course requirements are discussed in detail with parents. These meetings set the expectations for the upcoming school year. At the beginning of the year, parents are invited to an Open House. During the Open House, parents will be given copies of the school information, which includes detailed information about the school wide expectations, Dress for Success Plan and opportunities for participation in decisions related to the education of their child. Parents are invited to visit the children's classrooms and meet the staff. During the visit, teachers will provide parents with additional information about the class expectations, the assessments, and how parents can help at home. The same information will be available in the office to any parent who was unable to attend Open House. At the annual Title I Parent Meeting, information will be provided to the parents about the Title I programs, the curriculum, and academic assessments. Parents will learn about the school-wide program, how to schedule parentteacher conferences, and opportunities to provide input in decisions related to the education of their child. Sign-in sheets for the meetings will be maintained in the Title I box in the Assistant Principal's office. Information about the Title 1 program is also distributed through district composed letters sent home with the students at the beginning of the school year. Also sent home at the beginning of the year is the Parent Compact. The Parent Compact is also reviewed at a parent conference during the course of the year.
