Response: The District School Board of Pasco County gathers input through a variety of formats including annual parent surveys, a district Parent & Community Engagement Committee, School Advisory Councils, and the collection and analysis of aggregated data from parent workshops.

The District School Board of Pasco County Parent & Community Engagement Committee will meet each semester to gather input in the development and evaluation of the Parental Involvement Plan (PIP) and gather feedback regarding parent involvement initiatives. The committee is comprised of approximately 50% parents and/or community members, as well as 50% district staff. District staff represent essential departments/programs which include Title I, Student Support Services, Early Childhood and English to Speakers of Other Languages. Each department/program representative invites parents who represent these areas. The input from parents will be documented with meeting minutes, agendas and sign in sheets. Parents will participate in collaborative work groups to evaluate and develop the PIP each year.

Each Title I School in the Pasco County school district (DSBPC) develops their Parental Involvement Plan (PIP) in collaboration with parents via the School Advisory Council (SAC). The District School Board of Pasco County ensures that each Title I school meets with their SAC committee as required, and solicits feedback and input for the school-based Parental Involvement Plan as well as the use of Title I funds. Parents are invited through school publications, invitations, flyers, and postings on school websites. The SAC committees review data and address Title I issues. Parent input is solicited and encouraged throughout the school year as well.

Title I staff reviews and considers each school-based Parental Involvement Plan as an integral part of the LEA P.I.P. This Plan will be shared with the Title I schools to be shared with parents and other stakeholders.
