Such contact may be in person or using telehealth, as defined ins. 456.47, F.S. The mental health professional may be available to the school district either by contracts or interagency agreements with the managing entity, one or more local community behavioral health providers, the local mobile response team, or be a direct or contracted school district employee. Note: All initiated involuntary examinations located on school grounds, on school transportation or at a school sponsored activity must be documented in the Involuntary Examinations and Restraint and Seclusion (IERS) platform.

Describe the key EBP components that will be implemented.	
<p>Learning for Life, (LFL) is a Social-Emotional and Character Education Program for K-8 students- that focuses on 9 character attributes for student development and the Life Skills program. Universal prevention uses age-appropriate, grade-specific lesson plans to give youth skills and information that will help them make positive decisions independently.</p>	
<p>Explain how your district will implement evidence-based mental health services for students to improve the early identification of social, emotional, or behavioral problems or substance use disorders, as well as the likelihood of at risk students developing social emotional or behavioral problems, depression, anxiety disorders or suicidal tendencies, and how these will assist students dealing with trauma and violence.</p>	
<p>School-wide implementation from Administration, teachers, other staff members, and parents Lessons are designed to reinforce academic, social, ethical, and character development skills in various areas such as conflict resolution, decision, making, interpersonal relationships, practical life skills, self-esteem, writing and language skills, citizenship and personal fitness.</p>

Evidence-Based Program	Second Step for Middle Grades, and SEL for Adults (Second Step) and Step SEL for Adults
Tier(s) of Implementation	Tier 1, Tier 2
Describe the key EBP components that will be implemented.	
<p>The EBP in both programs has the same outcome, but through addressing very different stakeholders. According to Second Step for Adults, the program "intentionally focuses on building trust, managing stress, equality and belonging, and resilience and efficacy." This allows educators to create a safe, supportive environment for all students and one another. Teachers who are knowledgeable about their social awareness, and their social and emotional competencies are better equipped to handle their increased stressful working environment while ensuring they are fostering a responsive, safe, and culturally aware learning environment by utilizing the tools in the Second Step for Middle Schools. This program offers "25-minute lessons and discussion-based activities with distinct grade-level expectations."</p>	
<p>Explain how your district will implement evidence-based mental health services for students to improve the early identification of social, emotional, or behavioral problems or substance use disorders, as well as the likelihood of at risk students developing social emotional or behavioral problems, depression, anxiety disorders or suicidal tendencies, and how these will assist students dealing with trauma and violence.</p>	
<p>Many Second-Step Middle School Programs provide educators with early warning signs through discussion-based lessons, particularly those addressing conflicts, perspective-taking, relationships, self-awareness, self-management, and using a growth mindset. Many of the topics are indicators of a deeper issue and can be targeted for more intensive support. Documenting the lessons and intensity of the support will also provide evidence of its effectiveness.</p>	
<p>Explain how the supports will deliver evidence-based mental health care assessment, diagnosis, intervention, treatment and recovery services to students with one or more mental health or co-occurring substance abuse diagnoses and to students at high risk of such diagnoses.</p>	
<p>Although excellent for prevention and ongoing continuous learning opportunities, it does not address Mental health needs at the Tier 3 level. Additionally, and as suggested previously, the program when implemented with fidelity and combined with other "risk factors," for students who are teetering on the "At Risk" scale, this program will assist in determining if a more intensive intervention would be beneficial.</p>	

Evidence-Based Program	Sanford Harmony, harmony SEL
Tier(s) of Implementation	Tier 1, Tier 2
Describe the key EBP components that will be implemented.	
<p>Sanford Harmony, (SH) and Harmony SEL (HSEL) are systemic tools of the process including standardized student-report, parent-report, teacher-report measures, examining mental health surveillance data, or a structured teacher nomination process. Mental health promotion services and supports(Tier 1/2 are mental-health-related activities, including promoting positive, social, and behavioral skills and wellness, designed to meet all student's needs regardless of whether they are at risk for mental health problems. These activities can be implemented school-wide, at grade level, and or classroom level. Services may be support and mental health literacy:</p> <ul style="list-style-type: none"> **Anxiety or nervousness **withdrawn or isolation **Depressed mood/ acting out in school **Impulsive or risky behaviors 	
<p>Explain how your district will implement evidence-based mental health services for students to improve the early identification of social, emotional, or behavioral problems or substance use disorders, as well as the likelihood of at risk students developing social emotional or behavioral problems, depression, anxiety disorders or suicidal tendencies, and how these will assist students dealing with trauma and violence.</p>	
<p>This program provides the opportunity to screen and combine its measurement tools with other data points.</p> <p>Early Warning System (EWS) provided proactive rather than reactive services. Using data teams to analyze the screening will assist in targeted support and intentional social awareness for that student or students. Routine fidelity checks and monitoring progress, provide important feedback to staff and mental health team members for informed decision-making. Create a data system tracking evidence of success.</p>	
<p>Explain how the supports will deliver evidence-based mental health care assessment, diagnosis, intervention, treatment and recovery services to students with one or more mental health or co-occurring substance abuse diagnoses and to students at high risk of such diagnoses.</p>	
<p>This EPB can be implemented for Tier 1 and Tier 2 in the initial role of screening and preintervention, and intervention strategies.</p>	

Evidence-Based Program	Salus Care
Tier(s) of Implementation	Tier 2, Tier 3
Describe the key EBP components that will be implemented.	
<p>Salus Care is part of the larger Mental Health network known as Central Florida Behavioral Health Network or CFBHN. This organization contracts with six provider organizations for mental health and substance abuse services. Sakus Care and Cornerstone are part of the network and have local agencies who are available for any Tier 3 interventions and supports.</p>	
<p>Explain how your district will implement evidence-based mental health services for students to improve the early identification of social, emotional, or behavioral problems or substance use disorders, as well as the likelihood of at risk students developing social emotional or behavioral problems, depression, anxiety disorders or suicidal tendencies, and how these will assist students dealing with trauma and violence.</p>	
<p>Salus Care has licensed mental health providers and social workers who address and provide individual, group, or family therapy or consultation for general or special education students who have identified social, emotional, and/or behavioral needs that negatively affect emotional regulation and functioning. They have multiple locations across the Southwest Region and offer teletherapy as another avenue to support the ever-growing need for mental health support.</p>	
<p>Explain how the supports will deliver evidence-based mental health care assessment, diagnosis, intervention, treatment and recovery services to students with one or more mental health or co-occurring substance abuse diagnoses and to students at high risk of such diagnoses.</p>	
<p>Tier 3 supports can include outreach services, Some may include acute care, residential treatment, housing, medical, outpatient, and recovery support services. Cornerstone often works with the school's Mental Health and Crisis Teams to share information and collaborate on a holistic treatment plan for the student with parent permission.</p>

Resiliency Education includes key skills such as perseverance, gratitude, volunteerism, empathy, responsibility, mentorship, citizenship, and honesty. This toolkit provides resources through the FLDOE www.CPALMS.org

<p>Athenian will utilize the resources within the various sites (Florida AWARE Guidance Accessing Registries of Evidence-Based Mental Health Programs and Practices) to screen, educate, prevent, and intervene in the same way academic interventions are addressed through a multi-tiered system of support. The content areas to be taught are mental and emotional health, substance use and abuse prevention, internet safety and/or human trafficking, and character education.</p> <p>Athenian Charter School will also apply the Multi-tiered system of complete mental health support to provide a cross-system (including community, family, peers, juvenile justice., medicine, education, child welfare systems, etc.) collaboration to ensure all Florida youth access to the wide range of interventions with complete mental health. This endeavor will take time, but we are prepared to ensure the mandated hours of instruction in Resiliency Education are followed. The first step will be data teams collaborating with one another utilizing all data, academic, behavior, and screener results to provide Universal or Tier 1 instruction, and as the data projections indicate a possible higher level of factors present, which could develop into poor choices, level or Tier 2 interventions will be put in place with other programs and support systems to provide that group or student with the level of support for them and possibly parental supports through community resources. Tier 3 will be handled by our school counselor in collaboration with other healthcare providers in any of the Resiliency content areas of need. Tier 1 will be the universally supported with this program.</p>	
Explain how the supports will deliver evidence-based mental health care assessment, diagnosis, intervention, treatment and recovery services to students with one or more mental health or co-occurring substance abuse diagnoses and to students at high risk of such diagnoses.	
<p>As far as what has been provided through this program thus far, it will serve as a TIER 1 intervention only. The implementation of the FLDOE Resiliency Educational Toolkit will provide awareness and open discussions to educate students on the new language of resiliency skills, including grit, perseverance, gratitude, personal responsibility, volunteerism, critical thinking, problem-solving, empathy, citizenship, and honesty. The idea is to provide students with the tools and skillsets early on, beginning with these standards applied in GK-12. Still, until this schoolwide initiative is fully implemented, we must screen our students by combining a holistic profile based on academic and behavioral factors and emotional and social well-being. These toolkits will provide educators a starting point to refer further development on the subject noted to the school guidance counselor for further support.</p>

<p>Grades K-12 The 'School Assemblies Toolkit' contains materials such as fact sheets, conversation maps, and a school assembly template to guide schools in hosting their own events. Schools are encouraged to partner with community entities to host multimedia assemblies that will share real-life scenarios and science-based facts about substance abuse. Athenian Academy would contact some of our local organizations, such as Nami, Salus Care, or others listed in the CASTLE EVB programs offered in our area, to participate with us on these planned events.</p>	
<p>Explain how your district will implement evidence-based mental health services for students to improve the early identification of social, emotional, or behavioral problems or substance use disorders, as well as the likelihood of at risk students developing social emotional or behavioral problems, depression, anxiety disorders or suicidal tendencies, and how these will assist students dealing with trauma and violence.</p>	
<p>This school-wide project will be a forum to promote and distribute resiliency materials in schools, namely around the discussions, which can be sensitive in nature, but must be addressed. The trauma-informed material will especially be applicable as the anniversary of the 2022 Hurricane Ian becomes the topic during the month of September. This EBP implementation would be a school and community-based event that centralize parental involvement with student education, especially to equip them with a toolbox to utilize at home with their students once they leave school.</p>

<p>This is an EBP TIER 1 program, although if community organizers attend, parental involvement and resource aids can assist in adding the next level of support, which would be TIER 2.</p>

Grades K-8 Lessons educate students with information and strategies to prevent, recognize, and respond appropriately to bullying, cyberbullying, all types of child abuse, digital abuse, and other dangers.

Explain how direct employment of school-based mental health services providers (school psychologists, school social workers, school counselors and other licensed mental health professionals) will reduce staff-to-student ratios.

We have recently employed an employee with the credentials to service our student population for Tier 1 or universal awareness and educative Resiliency Education, including the new SEL and Substance Abuse standards, as well as the other mandatory Health topics, including mental health education through Resiliency, grit, and the other 12 components; Tier 2 supportive services including screening potential "at-risk" students identified through collaboration with staff and teachers, data reports including discipline records, absenteeism (chronic) and other risk factors. Tier 3 services will also be handled with a qualified staff member on-site in collaboration with community-licensed mental health responders and providers.

Describe your district's established policies and procedures to increase the amount of time student services personnel spend providing direct mental health services (e.g., review and revision of staffing allocations based on school or student mental health assistance needs).

Athenian Academy's goal is to use a comprehensive needs assessment ongoing and relevant to inform our decisions on how gaps can be addressed with existing or new services and supports. We will use this to prioritize selection areas of focus, programs, and strategies.

Describe the role of school based mental health providers and community-based partners in the implementation of your evidence-based mental health program.

Athenian Academy's Mental Health Team will foster communication between the social community and families by providing an updated and easily accessible resource map or guide for support and services to identify referral options. This will be available both in print and digitally. We will include resources to address the new topics of the Resiliency Education Standards.
