During Open House in October, the parents and students have a brief time to get acquainted with the teachers, see the classroom and get a quick overview of class expectations, curriculum and assessments plans for the year. All students' academic progress is monitored and parents are informed by Progress Book, progress reports and report cards. Throughout the school year, parents have the opportunity to attend meetings that will allow for their understanding of their child's academic progress and assessments. If a student is in danger if failing, academic meetings occur at various times of the school year to include the student, parent, and guidance counselor. IEP Meetings are conducted by our IEP Team and held throughout the year, by appointment.

The instructional coaches and administrators will analyze assessment data and work with the staff to interpret the data, so teachers can differentiate instruction for individual students and communicate results with parents during student-parent conferences and on Progress Book. Progress Monitoring Meetings are conducted throughout the school year.

Reports of student assessment are made available for parents to be picked up from the Guidance Office. Phone calls, School newsletters and Connect Ed messages are used to notify parents that this information is available if they have not received copies from the school.
