Response: Pasco County schools gathers input through a variety of formats including annual parent surveys, Parent & Community Engagement Liaisons, School Advisory Councils, and the collection and analysis of aggregated data from parent events and/or activities.

The Pasco County Parent & Community Engagement Liaison group will meet each semester to gather input in the development and evaluation of the Parental Involvement Plan (PIP) and gather feedback regarding parent involvement initiatives. The Parent and Community Liaison group consists of representatives selected by each Title I school in the district. Liaisons invite parents to participate in the input/feedback process to improve parent involvement initiatives. Input and feedback from parents will be documented with meeting minutes, agendas and sign in sheets. Parents will participate in collaborative work groups to evaluate and develop the PIP each year.

Each Title I School in the Pasco County school district develops their Parental Involvement Plan (PIP) in collaboration with parents via the School Advisory Council (SAC).
