We voted on what time worked best for parents at the first SAC/Boosters meeting. Parents decided 4:30 and 5:00pm worked best and that we would coordinate our parent nights with the SAC/BOOSTERS meetings as well. It is anticipated that this will increase parent involvement.

West also hosted a "boohoo" breakfast before school started on the first day of school for Kindergarten parents who needed additional support.

**Response:** West Elementary School is committed to serving our parents in a friendly and professional manner. Our front desk personnel is aware of the importance of making our parents feel welcome when visiting our school. A Spanish speaking employee is stationed at the front desk for our Spanish speaking parents in the morning and afternoon. West has a migrant recruiter that goes into the community to communicate and work with migrant families. All parents have access to Skyward so they can review their child's grades, attendance, and discipline. A parent resource was created in the front office, offering a computer and books/resources for parents to use with their child/ren at home. All parents are invited to the student led conferences where students share their current data and tell their parents how to help them better at home.

Parents can also use our school website and Facebook page to gain valuable information regarding school activities.

Student led award ceremonies will be held after quarters 1, 2, 3 and 4 and all parents/guardians are invited to attend.

Volunteer forms are completed by parents and community members so they can interact with and help students on school campus.

The school nurse collaborates with the community and parents by providing free dental care on school campus. Participating students may see the dentist when he is on campus, which is once a week. Teachers also send home weekly/ biweekly/ or monthly newsletters to communicate with parents on how to help their child at home and about events occurring at school.

**Response:** West Elementary School will host an annual meeting on September 19th, 2016 where information regarding the Title One Programs will be presented to parents. The meeting was advertised via Skylert phone calls, the school marquee, the school Facebook page, and notices sent home. At this meeting, assessment data will also be presented.

In addition to this meeting, there was an Open House on August 8th, 2016 where parents received bus, lunch, and dress code information. Parents met with their child's teacher and received information on parent/teacher conferences, the class curriculum, assessment plans, and strategies parents can use to help their child at home. The same information was placed in a packet and sent home for those parents who could not attend Open House. Sign in sheets were used to document this activity. Teachers also outlined student expectations, parent expectations, and teacher expectations during

open house.

Skyward allows parents to check on grades, attendance, missing assignments, discipline, etc. through the computer.

Many teachers also send home folders and planners daily to keep parents informed regarding their child's academic progress.

Copies of important notes are sent home with students and some teachers send home weekly/ biweekly/ monthly newsletters.

The West School Improvement Plan (SIP) and Parent Involvement Plan (PIP) will be presented to the School Advisory Council (SAC) on September 12th, 2016. The data and plans will be reviewed throughout the school year as well. SAC and Booster meetings occur once a month.

West uses the Florida State Standards to teach and assess students. I-Ready is used in Math and Reading to track student progress and intervene where needed in grades K-5. The Florida Standards Assessment is given to children in grades 3-5 in both Reading and Math. Fifth grades also take the Florida Comprehensive Assessment Test in Science. A passing score for all of the tests is a "3."
