Progress monitoring will be reported and student portfolios will be shared with parents three times a year during scheduled face-to-face parent conferences. Conferences will also be a time to receive up to date information on student grades, progress, needs, etc. Communication will be made via student agendas, monthly school-wide newsletters, email, and home visits will be made throughout the 2016-17 school year. Parents may request additional information at any time. At the end of the year, there are Parent Surveys randomly sent home. These surveys are used to generate information for school improvement.

Documents are translated by our bilingual staff and PCSB staff in order to communicate information to parents. Documents are translated into Spanish and Haitian Creole. Parents have access to a staff directory on our school website, with a direct link to the teacher's email address. Any teacher or staff member can be reached through the school phone number. Our secretaries will take messages when teachers or staff are unable to answer the phone call. Parents of ESE students have access to their child's progress on goals if they'd like to contact the ESE or general education teachers. Also, a report is sent home we each report card discussing how the child is doing in regards to meeting their goals. When students are going through the MTSS system, parents are notified at the end of the Tier 2 tracking when a meeting is requested with parents. teacher, and guidance counselor. This meeting often allows parents to see the data recorded and if the data is adequate, permission for testing and Tier 3 is requested. Parents with disabilities will be accommodated to the best of our school's ability. Requests made by parents with any special needs should be made directly to the school office. Assistance will be given by staff when disability is known. Home to school communication is sent in numerous ways, such as flyers sent home with the students. stickers in agendas, the school website, and/or the school marquee.
