Using this information with a parent survey, staff surveys and feedback on past parent workshops, a new Title 1 Parent Involvement Plan and a School Improvement Plan are developed and shared. As workshops are offered during the school year, parents provide feedback on the effectiveness of the programs and are asked to give suggestions on how the school can further assist in helping their child be more successful.

Kick Off to Summer Reading: Parents will participate in reading games and make-it, takeit activities that they can do at home over the summer with their child to help strengthen ELA skills. A free book and sight word flash cards will be given to students for summer practice.

Math Night: Publix Math night is held at a local Publix store and parents are provided information and strategies to help apply math to real life situations.

FL Standards Family Night: Parents of students in grades K-5 learn about the types of questions and skills their children will be responsible for mastering at each grade level. Resources for working with children at home are also made available for parents.
