Response: Spirit Elementary holds numerous family activities throughout the year to encourage families to take an active interest in their child's education. "Meet the Teacher" and "Open House" are held early in the school year. At these events, parents meet teachers and learn about curriculum and expectations for the year. Parents are encouraged to volunteer in a classroom and to join PTA. Information on Title 1 programs are shared before Open House, at the Annual Title 1 meeting using brochures and an informational video, this will also stream for the entire Open House in the Media Center and be available online. We also host "Parents to Kids" literacy program for families. We will also help Parents throughout the year learn to use an internet program allowing them to view attendance, grades, behavior and various test scores. Every parent is sent a form to sign up for a date and time to meet with their child's teacher. When parents arrive, they sign-in at the front office.
